Juan Fernando López Aguilar has been a Member of the European Parliament (S&D, Spain) since 2009. He is Chair of the Committee on Civil Liberties, Justice and Home Affairs, Member of the Committee of Inquiry to investigate the use of Pegasus, Member of the Conference of Committee Chairs, and Member of the ACP-EU Delegation. Prior to this, he was Minister of Justice of Spain (2004-2007) and Head of the Spanish Socialist delegation in the European Parliament (2009-2014). He has also served as a Member of the Spanish Parliament (2000-2009) and as Secretary-General of the Spanish Socialist Workers' Party in the Canary Islands (2007-2011). He has also been Professor of Constitutional Law at the University of Las Palmas and a Jean Monnet Professor of Law and European Integration. He has published 16 books and over a hundred articles on comparative law, federalism and regionalism, fundamental rights and judicial systems.



Jean-Christophe Dumont has been Head of the International Migration Division in the OECD's Directorate for Employment, Labour and Social Affairs since 2011. He joined the OECD secretariat in 2000 to work on international migration issues. He oversees the OECD annual flagship publication on migration; International Migration Outlook and numerous publications on the economic impact of international migration, as well as on migration management and the labour market integration of immigrants and their children in OECD countries. He has also worked on migration and development issues and on the international mobility of health workers. He holds a PhD in development economics from the University Paris IX-Dauphine and was a research fellow at Laval University, Quebec.



Alberto-Horst Neidhardt is a policy analyst in the European Migration and Diversity programme of the European Policy Centre (EPC). His research areas include asylum, migration and integration matters, with a particular interest in the politics of migration. He also teaches comparative law and legal pluralism at the University of Antwerp. He holds a PhD and an LLM in comparative, European and international laws from the European University Institute and an MA in international and comparative legal studies from SOAS, University of London.



Jadwiga Rogoża is a senior fellow at the Warsaw-based Centre for Eastern Studies, specialising in Ukraine; she is also an expert on Russia. She cooperates extensively with Polish state administration and EU institutions, non-governmental organisations and periodicals focusing on eastern European affairs and the media. She served as a diplomat at the Polish Embassy in Moscow from 2015 to 2018. Rogoża is the author of over 100 reports and analyses concerning Russia and Ukraine. She graduated in English studies from Lodz University and in political science from Warsaw University.



Hanne Beirens is Director of Migration Policy Institute Europe, where she specialises in European Union policies relating to asylum and migration, human trafficking, labour migration and youth. Previously she worked as a Lead Managing Consultant for ICF Consulting, where she focused on impact assessments, and evaluations for the European Commission, particularly on EU asylum and migration policy, as well as developing products within the European Migration Network (EMN). She has also worked for the United Nations High Commissioner for Refugees (UNHCR) and as an independent consultant for the International Labor Organization (ILO) and the Quaker United Nations Office (QUNO). She holds an MA in race and ethnic relations and a PhD in sociology and ethnic relations, on the participation of minors in armed conflict, both from the University of Warwick.
