DRAFT Work Programme for the Tourism Task Force 1st half 2023

- 1. <u>Tourism Task Force (TTF) Meetings</u> (during TRAN committee slots)
- End of January or early March 2023 (TBC): Exchange of views with <u>Commissioner Breton</u> (as part of the structured dialogue) on the implementation of the <u>EU Tourism Agenda 2030</u> and, depending on the date confirmed (January or March), update on new developments for the tourism sector;
- **Spring 2023 (tbc)**: Exchange of views on the <u>European Commission's initiative on short-</u>term rentals (STRs) with stakeholders;
- **June 2023:** TTF meeting on the 'A competitive and sustainable Tourism addressing the global energy crisis and emissions' reduction targets';
- 2. Extraordinary TTF meetings (only TTF Members) or Steering Group meetings

Only if specifically needed / requested.

3. Legislative and Non-Legislative Work:

- 1) Own-initiative Reports: an own-initiative report on tourism matters could be considered following the adoption of the EU Agenda for Tourism (to be confirmed depending on slots available and in agreement with TRAN Coordinators).
- 2) TRAN secretariat keeps an eye on possible legislative and non-legislative proposals from the Commission and makes sure TRAN is <u>involved in work with other committees</u> on relevant tourism aspects. Ongoing and upcoming files:
 - Opinion to REGI INI on the Assessment of the new communication of the European Commission on Outermost Regions;
 - Opinion to short-term rentals (IMCO in the lead; attributed by TRAN Coordinators on 29 November 2022);
 - Upcoming legislative proposal on a revision of the Package Travel Directive (Commission's estimates the publishing of their proposal in Q4 2022);
 - Upcoming legislative proposal on the Revision of the passenger rights regulatory framework (Commission's estimates the publishing of their proposal in Q2 2023).

3. Public Hearings and Studies:

- There are no specific tourism related issues among the selected proposals for <u>public hearings</u> for the first half of 2023 (agreed by TRAN Coordinators on 3 October 2022). New proposals could be submitted for the 2nd half of 2023 (through Coordinators).
- TRAN Coordinators agreed on a <u>study</u> on the impact of new climate policies on the outermost regions in the transport and tourism sectors, and mobility poverty in outermost regions.

4. Cooperation with Other EU Institutions and Stakeholders

- Establishing and maintaining contacts with the **Swedish Presidency** by TRAN Chairwoman and the TTF Steering Group:
 - ➤ 31 January 2023: EoV in TRAN committee meeting with the relevant Minister on tourism matters;
 - ➤ Possible participation in the informal Tourism Council (tbc);
 - ➤ Possible meeting of the representative from the Swedish Presidency and the TTF Steering Group Members on the topical issues;
- Upholding close cooperation with the Commission (Commissioner Breton in the context
 of the structured dialogue and DG GROW) at the political and operational levels (TTF
 Steering Group and TRAN Secretariat);
- Maintaining close cooperation, setting up meetings and considering joint initiatives with key tourism stakeholders (including entities, such as the UNWTO, ETC, WTTC, OECD and PATA, for example a dialogue with global partners on the theme "Tourism outlook to the World";
- Upholding close cooperation with the Committee of Regions (CoR). The Commission for Natural Resources (NAT) has a meeting on 31st January 2023, where the proposal on STRs is on the agenda; TTF Members could be invited to share the EP position.

5. Other Tourism-Related Activities:

- 1) <u>Budgetary matters</u>: Pilot Projects and Preparatory Actions coordinated preparation and follow-up of PPs and PAs in tourism area;
- 2) <u>TRAN missions</u> usually cover subjects related to tourism. Missions and ad-hoc delegations to the following countries are planned during the 1st half of 2023:
 - Week 8: Ad hoc delegation to Saudi Arabia
 - Week 14: Ad-hoc delegation to Indonesia
 - Week 20: Mission to Italy (Genova/Naples)
 - Week 25: Mission to Spain (Aragón, Bilbao).
- 3) Members attendance at the high-level conferences/events on tourism matters on *ad hoc* basis.

4) TTF keeps the right to propose and take appropriate initiatives, depending on circumstances and situation (letters, Motion for Resolution, Plenary debates etc.).
