4. Debate on the Estrela (EP) – Heli Rojas (Parlandino) report: ‘Prevention of natural disasters in Europe and Latin America’ – Committee on Social Affairs, Human Exchanges, the Environment, Education and Culture

9.3 The motion for a resolution tabled by the Committee on Social Affairs, Human Exchanges, the Environment, Education and Culture, rapporteurs Ms Edite Estrela (EP, S&D) and Mr Hector Helí Rojas (Parlandino), on Prevention of natural disasters in Europe and Latin America was approved.
