Coordinators' decisions and recommendations

1. Appointment of rapporteurs and rapporteurs for reports and opinions

Decision:

2. Hearings

Decisions:

3. Missions/ad hoc delegations

a) 64th session to the CSW, New York (USA), 15-19 March 2020

b) The 2020 UNFCCC Climate Conference (COP26), Glasgow (United Kingdom), November 2020

Decision:

Request authorisation for 5 DEVE Members to take part in the ad hoc delegation.

c) The 15th Conference of the Parties to the United Nations Convention on Biological Diversity, in Kunming (China), 27-30 October 2020

Decision:

Request authorisation for 5 DEVE Members to take part in the ad hoc delegation.

4. <u>Studies</u>

Decision:

- Request a study on cash transfer.
- Political Groups to prepare a proposal with a view to the next Coordinators meeting.

5. Parliament's work to monitor implementation of SDGs

Decision:

- Draft an own-initiative report on the implementation of the Sustainable Development Goals in developing countries (S&D, 2 point).
- Mandate the Chair to explore the possibility of drafting a joint Committee resolution with ENVI that holistically will include the external (developing countries) and internal (Union) dimension of the implementation of the SDGs.
- Organise an ad hoc delegation to the 2020 High-level Political Forum in New York (USA) in July 2020.

6. Requests for items on the Committee agenda

Decision:

Organise:

- A joint DEVE-AFET exchange of views on the programming for the new external financial instruments (2021-2027), inviting the ECDPM, the European Commission and the EEAS.
- An exchange of views with DROI with the Special Rapporteur on the rights of indigenous peoples
- An exchange of views with the European Commission on Eritrea.
