Coordinators' decisions and recommendations

1. Appointment of rapporteurs and rapporteurs

- Legislative reports
- i) Amended proposal for a Regulation of the European Parliament and of the Council establishing Horizon Europe the Framework Programme for Research and Innovation, laying down its rules for participation and dissemination; Decision of the European Parliament and of the Council on establishing the specific programme implementing Horizon Europe the Framework Programme for Research and Innovation; Regulation of the European Parliament and of the Council establishing the Neighbourhood, Development and International Cooperation Instrument; Regulation of the European Parliament and of the Council establishing rules on support for strategic plans to be drawn up by Member States under the Common agricultural policy (CAP Strategic Plans) and financed by the European Agricultural Guarantee Fund (EAGF) and by the European Agricultural Fund for Rural Development (EAFRD)

Decision

Allocate the provisions concerning the NDICI within the "omnibus" proposal to the corapporteurs for this file, Rasa Jukneviciene (EPP) and Charles Goerens (Renew) (0 points).

ii) Proposal for a Regulation of the European Parliament and of the Council amending Regulation (EU) 2017/1601 establishing the European Fund for Sustainable Development (EFSD), the EFSD Guarantee and the EFSD Guarantee Fund - 2020/0107 (COD)

Decision

Allocated to the NDICI co-rapporteurs, Rasa Jukneviciene (EPP) and Charles Goerens (Renew) (0 points).

iii) Proposal for a Regulation of the European Parliament and of the Council amending Regulation (EC) No 1257/96 of 20 June 1996 concerning humanitarian aid

Decision

Allocated to the Standing Rapporteur for Humanitarian Aid, Norbert Neuser (S&D) (0 points).

• Non-legislative reports

i) The impact of the biodiversity crisis on the achievement of the 2030 Agenda in developing countries, notably on indigenous people

Decision

Continue to request a DEVE own-initiative report. In case of no authorisation, revert the matter back to the Coordinators.

• Legislative opinions

i) Proposal for a Decision of the European Parliament and of the Council amending Decision No 1313/2013/EU on a Union Civil Protection Mechanism 2020/0097 (COD)

Decision

Agree to association, under Rule 57, and draft an opinion in the form of a letter by the Chair.

• Non-legislative opinions

i) ENVI INI on EU Biodiversity Strategy for 2030: Bringing nature back into our lives

Decision

Explore the possibility to be associated under Rule 57.

2. Annual Structured Dialogue with the Commission

Decision:

Coordinators reiterated that such a dialogue should be based on a political discussion, and not be held in written form.

3. Parliament's work to monitor implementation of SDGs

Decisions:

- Follow on line the proceedings of the high-level political forum on sustainable development (HLPF) to be held in July.
- Participate in virtual side-events.
- Organise an extraordinary DEVE meeting with Achim Steiner, Administrator of the United Nations Development Programme (UNDP).

4. Post-Cotonou negotiations

Decision:

Continue exploring all possible lines of action to ensure that the EP position on the strengthening of the parliamentary dimension of the future agreement is duly taken into account.

5. Requests for items on the Committee agenda

Decision:

Organise, when possible:

- An exchange of views with the FAO.
- A presentation of the study on private sector capacities in developing countries.
