Othmar Karas has been a Member of the European Parliament (Austria, EPP) since 1999. He is the First Vice-President of the European Parliament and is responsible inter alia for information and communication policy, the Members' Research Service and library (both within EPRS), and relations with NATO, the OSCE, World Bank and the IMF. He is a member of Parliament's Bureau, of the EP Committee for Economic and Monetary Affairs (ECON), and the EP Delegation for relations with the United States. Prior to his election to the European Parliament, he was Member of the Austrian Parliament and Secretary-General of the Austrian People's Party. He is a visiting lecturer at Danube University Krems, Vienna University for Economics and Business, and University of Vienna. Since 1998 he has been President of the Austrian Aid Organisation 'Hilfswerk Österreich' and, since 2009, founder and speaker of the non-partisan citizen's forum 'Bürgerforum Europa'.



Valérie Hayer has been a Member of the European Parliament (France, Renew) since 2019. She is co-President of the Renew Europe Group's French delegation and Renew Europe's spokesperson on budgetary and financial affairs. She is a member of the European Parliament's negotiating team on the long-term EU budget (Multiannual Financial Framework) and EP co-rapporteur on the sources of revenue for the EU budget ("own resources"). She is also a substitute member of the Industry Committee and negotiated on the Digital Services Act. Over this legislature, she has taken the lead on files such as the new own resources, NextGeneration EU, the 2021-2027 EU budget, the Brexit Adjustment Reserve, the Carbon Border Adjustment Mechanism, and the reform of the EU's carbon market (ETS). She was previously a municipal councillor, and also Vice-President of the Departmental Council in France.



Pascal Lamy is the President of the Paris Peace Forum and of the European branch of the Brunswick Group. He coordinates the Jacques Delors Institutes (Paris, Berlin, Brussels). He is an affiliated professor at the China Europe International Business School CEIBS (Shanghai) and at HEC (Paris). He was previously Trade Commissioner (1999-2004), Director General of Crédit Lyonnais (1994-1999), Chief of Staff of the President of the European Commission, Jacques Delors and his G7 Sherpa (1985-1994), Deputy Chief of Staff of the French Prime Minister (1983-1985) and to the French Minister of the Economy and Finance (1981-1983). From 2005 to 2013, he served two consecutive terms as Director General of the World Trade Organization (WTO).



Klaudie Mrkusová is a policy officer in the Directorate-General for Energy of the European Commission, where she mainly deals with energy research and new energy technologies. Besides, she promotes and represents the voices and opinions of the new generation as vice-chair of the FAN - the youth and alumni network of the European Forum Alpbach. In the past, she managed a Viennese e-mobility startup, founded an NGO focusing on education of children in Togo, and gathered experience in French diplomacy and the OECD. She graduated from SciencesPo Paris with an exchange at the University of Hong Kong.
