MINUTES

Twelfth Ordinary Plenary Session, 12 December 2019, 9.00-11.00 and 13 December 2019, 11.00-13.00

Seat of the Latin-American Parliament, Panama City, Panama Room: Auditorium

The meeting opened on Thursday, 12 December 2019 at 9.00 with the acting Latin American Co-President and President of Parlatino, Senator Jorge Pizarro Soto, in the Chair.

Opening of the Ordinary Plenary Sitting: election of Co-Presidents and Co-Vice-Presidents by both components of the Assembly

The acting Latin American Co-President announced that the Members of the European component, elected in the European elections of May 2019, had put forward Javi López MEP as Co-President of the Assembly. Mr López was elected by acclamation.

The European Co-President announced on behalf of the Members of the Latin American component that Senator Jorge Pizarro Soto had been formally nominated for the post of Co-President of the Assembly. Mr Pizarro was elected by acclamation.

The Co-Vice-Presidents of the Assembly were then elected. The European component, elected in the European elections of May 2019, had nominated the following candidates:


The European component's proposals were adopted by acclamation.

The Latin American Co-President announced that the Latin American component's Co-President and Co-Vice-Presidents would be elected in March 2020.

Official opening of the 12th Ordinary Plenary Session and Commemoration of the 55th anniversary of the Latin American Parliament

The session was adjourned at 11.00 and resumed at 9.00 on Friday, 13 December 2019, with Jorge Pizarro (Co-President) and Jordi Cañas (Co-Vice-President) presiding.

1. Adoption of the draft agenda of the Ordinary Plenary Session

The draft agenda was adopted.

2. Approval of the minutes of the eleventh Ordinary Plenary Session

The minutes of the plenary session were approved.

3. Announcements by the Co-Presidents of the Assembly, including the decisions of the Executive Bureau at its meetings of February and October 2019

4. Debate on the report of the Committee on Political Affairs, Security and Human Rights

Mónica Silvana González (EP, S&D), the European co-rapporteur, presented the draft report on 'Regulating lobbying activities in the EU and Latin America and the Caribbean', which the Committee had approved at its meeting of 28 February 2019 in Santa Cruz de la Sierra (Bolivia).

The European co-rapporteur explained that the report stressed the need to regulate relations between public authorities and lobby groups and highlighted practical ways to ensure compliance with the rules in this area, guarantee transparency and prevent conflicts of interest. Ms González added that many countries in both regions had already made progress in regulating the activities of lobby groups, by introducing various rules, codes of conduct and registers. She also highlighted the EU institutions' adoption of the transparency register.

Against this backdrop, the draft report included proposals from different regulatory traditions, highlighting six fundamental elements:

- the need for a clear definition of lobby groups;
- transparency and the need for lobby groups, their objectives and sources of funding to be made public, and for registers to be reliable;
- effective oversight of the rules governing the activities of lobby groups and the existence of dissuasive sanctions to punish non-compliance;
- fair conditions for participation in decision-making as a fundamental requirement for democracy;
- the need to regulate and establish stricter rules and oversight mechanisms that avoid 'revolving doors' between the public and private sectors;
- protection for whistleblowers.

Roger Haroldo Rodas Melgar (Parlacen, Guatemala) stood in for the Latin American co-rapporteur, Angel Rozas (Parlatino, Argentina), who was absent. Mr Rodas congratulated the European co-rapporteur on having drafted a very comprehensive report.

5. Exchange of views with the FAO on 'the role of parliaments in achieving the Sustainable Development Goals: progress and challenges for 2030'

Luis Lobo, Technical Officer of the Spain-UN Food and Agricultural Organisation (FAO) Programme, FAO Regional Office for Latin America and the Caribbean, introduced the topic by thanking the parliaments of Latin America and the Caribbean and Europe for their support in opening a space for dialogue and recognising the magnitude of the challenges involved in eliminating malnutrition in the world. He also stressed the work undertaken by EuroLat in that area, citing the Resolution on Food Security adopted in 2014.

Mr Lobo outlined some of the challenges in meeting the 2030 Agenda and particularly Sustainable Development Goal No 2 (SDG 2), entitled 'Zero Hunger'. Some 2 billion people around the world lacked access to sufficient nutritious food, 820 million of whom suffered from hunger, and 161 million children under five years old had stunted growth. In Latin America and the Caribbean, some 42.5 million individuals still suffered from the scourge of hunger, although its prevalence had fallen from 11.9% to 6.5% of the population between 2000 and 2018. More serious still, the trend has reversed in recent years, with of hungry people growing since 2015. Hunger was chiefly a reflection of inequality, of which indigenous peoples, Afro-descendants, and other poverty-stricken groups bore the brunt. Investing in good nutrition for all would therefore not only improve the health of societies but also contribute to the cognitive development of individuals and thus to the development of countries' economic, cultural, and social potential.

There was, meanwhile, a global problem of people being overweight. An estimated 39% of adults in the world are overweight and 13% suffer obesity. While about 153 million adults in the EU suffer from obesity, almost a quarter of the adult population in Latin America and the Caribbean does. It was a problem that needed to be seen from a gender perspective, since obesity is more prevalent in women than in men: 15% versus 11% worldwide. These figures were alarming, especially since malnutrition by excess is a factor contributing to the development of diseases, such as cardiovascular disease and diabetes, which accounted for 71% of deaths worldwide in 2016. This public health problem was also incurring enormous costs for governments, using up funds that that could be earmarked to meet other needs. The causes of food insecurity, obesity and overweight included inequality, current models of production and consumption, population growth, urbanisation, conflict and climate change; all factors with a direct impact on rural livelihoods and forced migration. Given that food was all-important for human life and potential development, Mr Lobo noted that no progress could be made in sustainable development or combating climate change without beginning by eliminating hunger, preventing overweight and obesity, and transforming current food systems into more stable and healthy ones.

In this context, the FAO considered it crucial that parliaments made commitments on the zero-hunger objective. Given the complexity of the problem, its multi-sectoral nature and the need for medium- and long-term policies to address it, parliamentarians had a strategic role to play in achieving a healthier and more sustainable society and planet. Mr Lobo stressed that members of parliament were key protagonists in building state policies through legislation and in carrying out oversight activities to enforce it and ensure its long-term impact, by virtue of their capacity as citizens' representatives and their democratic functions and ability to meet challenges by building consensus and by means of plurality and constructive dialogue. The FAO offered parliaments technical support, scientific data and its capacity to coordinate with various stakeholders and facilitate dialogue.

Mr Lobo concluded by proposing the FAO's cooperation with the EuroLat Assembly on three lines of joint work:

- Strengthening the Assembly's work in the field of food and nutrition security, in order to address the challenges linked to the achievement of 'Zero Hunger' and the 2030 Agenda, such as obesity and overweight, an adequate gender approach, a territorial approach to addressing hunger and poverty, the creation of sustainable and healthy food systems and their link to climate change, among others.
- Establishing a permanent space for exchanges of experiences between Europe and Latin America on the parliamentary tasks linked to SDG 2 and other sustainable development goals pertaining to healthy and sustainable food systems.
- Strengthening international cooperation supporting parliamentary work to reduce hunger and malnutrition in Latin America and the Caribbean.

Mr Lobo expressed his conviction that these proposals would help the parliaments of both regions to strengthen their exchange processes with a view to addressing common challenges and, in general, to taking action to honour the global commitments concerning SDG 2 and the agreements signed at the first Global Parliamentary Summit against Hunger and Malnutrition, held in October 2018 in Madrid.

They were also likely to help EuroLat's regional and subregional member parliaments increase their capacities, with technical support from FAO and other specialised agencies, to identify the problems and possible legislative solutions involved in achieving SDG 2 and helping pass laws able to address the new challenges for food systems connected with climate change and forced migration. He also believed that they would help ensure the proper implementation of national legislation on food and related issues.

Lastly, Mr Lobo mentioned the success of the 'Parliamentary Front against Hunger in Latin America and the Caribbean (PFH-LAC)', a regional network of lawmakers committed to food and nutritional security set up 10 years ago with the support of the FAO, Parlatino and the Spanish Agency for International Development Cooperation (AECID). PFH-LAC maintained a presence in 21 national congresses and five regional and/or subregional parliaments: Parlatino, Parlandino, Parlacen and Parlasur. Its main

achievements included passing and implementing 43 national laws on food and nutrition security, family farming, food loss and waste, school meals, agro-ecology, food labelling, specific taxes and trust funds for the fight against hunger. He also stressed the key role played by the regional parliaments of Latin America and the Caribbean in this process, such as in the model laws (on the right to food, food security, family farming, school meals, artisanal fisheries and aquaculture, among others), drafted by Parlatino which served as a benchmark for drawing up national legislation. Similarly, FPH-LAC's success had inspired other similar initiatives such as the 'European Parliamentary Alliance for the Fight against Hunger and Malnutrition' at the EP, the 'Spanish Parliamentary Alliance for the Right to Food' and other comparable processes in Africa and Asia.

6. Vote on the motion for a resolution contained in the report of the Committee on Political Affairs, Security and Human Rights

The motion for a resolution on 'Regulating lobbying activities' tabled by the Committee on Political Affairs, Security and Human Rights, with Monica Silvana Gonzalez (EP, S&D) and Angel Rozas (Parlatino, Argentina) as rapporteurs, was adopted unanimously.

7. Other business

As decided by the Executive Board, two Bolivian Members of the Assembly were offered the floor to explain the current situation in their country.

Mery Elina Zabala Montenegro (Parlatino) was first to speak. She stated that that no coup d'état had taken place in Bolivia, but the situation was rather the result of the frustrations at the 14 years of President Evo Morales's government, particularly its failure to abide by the result of the 2018 referendum, which had decided against President Morales's re-election, and with Constitutional Court ruling allowing him to stand, in breach of the country's Constitution. She spoke out against corruption under President Morales' administration and the lack of respect for human rights. She insisted that that the interim President Jeanine Añez had been sworn in in full accordance with the Constitution.

Edgar Mejía Aguilar (Parlatino) then took the floor. He denounced the coup d'état in Bolivia, the violation of human rights and the excessive use of military and police force. He stated that the election of the interim President was illegal, since he lacked the necessary quorum in the Senate and because President Evo Morales would not complete his constitutional mandate before 22 January 2020. The presidential candidate Carlos De Mesa had called for mobilisation before the final results of the 20 October elections had been known. Mr Mejía denounced what he qualified as a wave of excessive violence

fomented by a civic group which had cost 33 lives, and called for an international investigation.

10. Date and place of the next meetings of the Standing Parliamentary Committees of the EuroLat Assembly

The Co-Presidents announced that the next meetings of the parliamentary committees would, in principle, be held from 18 to 22 May 2020 in the city of Santa Fé (Argentina).

They added that the 13th Ordinary Plenary Session of EuroLat could be held in September 2020 in Germany.
