1. CHAIR'S ANNOUNCEMENTS

Update on the MFF

<u>Update on Commissioner Breton's appearance in BUDG</u>

Despite repeated invitations to Commissioner Breton to come to the Committee on Budgets to present his plans for future defence policy and their budgetary implications, the Commissioner has not replied. The Chair will write to the Commissioner to express disappointment and ask for improved cooperation in future, in line with the Framework Agreement on relations between the European Parliament and the European Commission.

The Coordinators further decided to seek to include on the plenary agenda a debate with Commissioner Breton.

Update on MFA+

The Chair will write to the Commission to request that the Committee on Budgets receive the monthly reports Ukraine submits to the Commission under the Memorandum of Understanding setting out the conditions for the use of macro-financial assistance.

2.2. Endorsement of the opinion in form of a letter to ITRE on the European Union Agency for the Cooperation of Energy Regulators (ACER) and ITER

The Coordinators agreed to put the draft opinion to the vote at the BUDG Committee meeting of 8 June 2023.

2.3. BUDG/CONT hearing on staffing in the decentralised agencies

The Coordinators approved in principle the draft programme for the 27 June hearing on 'Personnel and other resources at EU Agencies, Bodies and Joint Undertakings', setting a deadline of Friday 26 May (close of business) for groups to send any proposals on agencies, bodies or joint undertakings to be invited and entrusting the secretariat with finalising the programme in conjunction with the CONT Committee secretariat.

The Coordinators also agreed to scrutinise the staffing situation in the Commission's executive agencies at a separate BUDG meeting.

2.4. Update on the European Parliament budget for 2024

In the presence of Mr Ušakovs, rapporteur for the 2024 European Parliament budget, and Mr Mureşan, general rapporteur for the 2024 budget.

The Coordinators discussed the state of play on the Parliament's estimates ahead of the adoption of the 2024 draft budget.

2.5. Exchange of views on the outcome of the Fit for 55 trilogues: budgetary aspects

Coordinators held an exchange of views on the outcome of the Fit for 55 negotiations, agreeing that the BUDG Committee objectives were met in part and that, in future, more effective coordination of Parliament's legislative and budgetary powers would yield better results by ensuring the involvement of the budgetary authority in the work on upcoming legislation underpinning the introduction of new own resources.

2.6. Proposal for a meeting between the Committee on Budgets of the European Parliament and the Committee on Budgets of the Verkhovna Rada

The Coordinators agreed to hold a joint meeting with the members of the Rada's Committee on Budgets on 19 July in the afternoon, with Rada members participating remotely. The Coordinators also set a deadline of 30 May (close of business) for groups to send written questions for the Rada counterparts with a view to determining the precise scope of the meeting and the issues to be discussed.

Coordinators agreed that political groups should ensure proper attendance of Members at this meeting.
