2.3.2. Proposal for a Regulation on European Union labour market statistics on businesses, repealing Council Regulation (EC) No 530/1999 and Regulations (EC) No 450/2003 and (EC) No 453/2008 of the European Parliament and of the Council (2023/0288(COD) - COM(2023)0459)
