1. Allocation of reports and opinions

1.1. Legislative Opinions

- 1.1.1. Advanced Framework Agreement between the European Union and its Member States, of the one part, and the Republic of Chile, of the other part EMPL/9/13402 COM(2023)0432
 - Coordinators decided not to draw up an opinion.
- 1.1.2. Amending Directives 1999/2/EC, 2000/14/EC, 2011/24/EU and 2014/53/EU as regards certain reporting requirements in the fields of food and food ingredients, outdoor noise, patients' rights, and radio equipment (COM(2023)0639 2023/0369 (COD))

2. EMPL priorities in view of the end of the legislature

- Coordinators decided to:
 - o identify all six ongoing OLP files under EMPL lead as priority files, expected to be provisionally agreed before the end of the legislature, and inform the CCC thereof;
 - o flag to the CCC files under the lead of other committees where EMPL has a strong interest and involvement that should also be prioritised;
 - o revisit other upcoming files on a case by case basis to decide how far they could be brought before the end of the term.

3. Preparation of missions, hearings and related activities

3.1. Mission to Amazon - update

- Coordinators took note of the update concerning the EMPL mission to Amazon and decided to inform President Metsola of Amazon's unwillingness to receive the EMPL delegation. Coordinators also decided to organise, in the beginning of 2024, an exchange of views with workers and Amazon management, if willing to participate, on the working conditions in the warehouses. The Chair counts on the participation of at least one MEP from each political group.

3.2. "Visit" to Belgium - update

- Coordinators decided that different Members can participate in the different meetings with the upcoming Belgian Presidency.

4. Special report on "Supporting people with disabilities – Practical impact of EU action is limited", by the European Court of Auditors

- Coordinators decided to invite the ECA to present the special report in committee, possibly together with CONT, if time allows during the 2023 Disability Rights Week.

5. EMPL Coordinators meeting dates for 2024

- Coordinators endorsed tentative dates of Coordinators meetings in the first half of 2024.

6. Petitions received for information

- 6.1. Petition No 0510/2023 by A. E. (Estonian) on access to medical care in all Member States of the EU
 - Coordinators took note of the above-mentioned petition.

8. Any other business

8.1. European Platform on Combating Homelessness

- Coordinators decided to invite the European Platform on Combating Homelessness for an exchange of views in committee at the earliest possibility.

8.2. ILO Violence and Harassment Convention, 2019 (No 190)

- Coordinators were updated by the Chair on the progress in respect of the upcoming consent procedure. Coordinators mandated the Chair to discourage any possible challenge of EMPL competence by other committees.

8.3. Follow-up to the EMPL informal visit to the ECB on 16 October 2023

- Coordinators decided to use the rules applicable to missions outside the three places of work, including on the participation of accompanying Members who are not EMPL Members, to any future EMPL informal visits or similar activities.

8.4. Belgo-Spanish informal working groups

Coordinators were informed by the Chair on the ongoing activities of two informal working groups created by the Spanish and Belgian Presidencies: on the European Pillar of Social Rights and on social investment. Coordinators decided to use the upcoming "visit" to Belgium to obtain more information on the involvement of the European Parliament in the BE Presidency's event on the EPSR on 15-16 April at La Hulpe.
