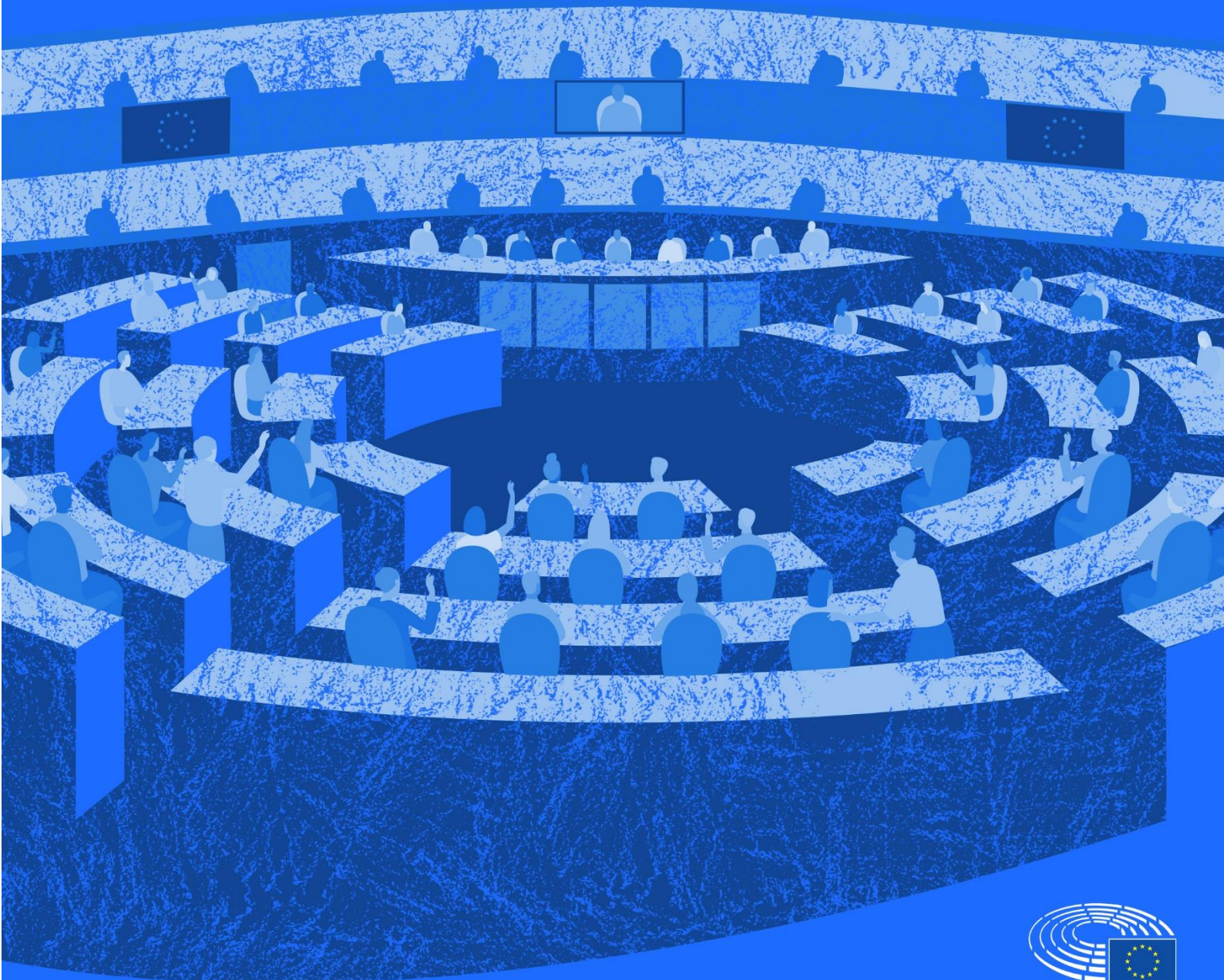

## Foreword by the outgoing Chair



During the previous 9th legislative term, the Committee on Budgetary Control (CONT) took significant strides in enhancing the transparency, accountability, and efficiency of EU funding. A key focus was placed on three main initiatives, reflecting CONT's commitment to upholding the highest standards of financial integrity within the European Union.


Firstly, under the discharge procedure, the European Parliament exercises its exclusive right to assess that the budget has been spent legally and properly, whilst respecting the principles of sound financial management. CONT Committee leads the discharge procedure and scrutinises the work of the EU institutions and bodies. Its role is fundamental in reinforcing the transparency and accountability of budgetary management, standing as a guardian of the EU's financial interests.

Notably, CONT emphasized the critical need for transparency in the allocation and utilisation of EU funds by advocating for mechanisms that ensure the identification of final beneficiaries of all EU funding. This initiative aimed at enhancing the traceability of funds, thereby preventing fraud and ensuring that financial resources effectively reach their intended targets. Digitalisation of control and audit functions, while reducing bureaucracy, were further drivers of the committee's work. By pushing for a high level of transparency, CONT also sought to build trust in EU funding mechanisms and ensured that every euro spent contributes to the Union's goals.

Secondly, the committee highlighted the importance of performance-based funding programmes including the Recovery and Resilience Facility (RRF) and the Ukraine Facility. CONT advocated for the design and implementation of these programmes to be anchored in principles of sound financial management and effective budgetary control. The objective was to link funding more closely to results, ensuring that EU funds not only support policy objectives but also deliver tangible outcomes. This approach was seen as crucial in maximising the impact of EU spending and reinforcing the efficiency of financial allocations while increasing accountability towards EU citizens.

Lastly, CONT took a firm stance on the issue of the Rule of Law and its link to the EU budget in all Member States. The committee underscored the necessity of stringent oversight mechanisms to ensure that EU funds are not only used in accordance with financial rules but also in a manner that respect the Union's values, including the Rule of Law.

I hope you will enjoy looking back on our achievements as much as I have!

## Committee mandate

(based on its competences in the RoP as described in Annex VI and legal basis)

This document gives an overview of the main activities and initiatives of the Committee on Budgetary Control (CONT), which it has been my privilege to chair during the 9th legislative term. In addition to providing brief descriptions of the main reports, it includes detailed lists of handled opinions, missions and ad-hoc delegations, public hearings and other events.

CONT plays an important role within the European Union's framework, ensuring the effective and transparent use of the Union's budget and safeguarding the financial interests of the Union. The committee is tasked with a broad range of competences, each critical to maintaining budgetary discipline and integrity across the Union's institutions and activities.

First and foremost, CONT is responsible for overseeing the implementation of the Union's budget and of the European Development Fund. This includes making decisions on the Discharge process, a formal endorsement of how the budget has been implemented. The importance of this responsibility cannot be understated, as it directly relates to the accountability and financial management of the Union as a whole.

Additionally, CONT handles the closure, presentation, and auditing of the accounts and balance sheets of the Union, its institutions, and bodies financed by it, including the establishment of appropriations to be carried over and the settling of balances. This ensures a transparent and accountable financial reporting system.

The committee also oversees the financial activities of the European Investment Bank (EIB), ensuring that the EIB's operations align with the Union's financial regulations and policies. This oversight is crucial for maintaining the integrity of the Union's financial activities and investments.

A significant part of CONT's mandate involves monitoring the cost-effectiveness of the Union's financing in implementing its policies. This includes the ability to involve specialized committees upon request for the examination of special reports by the Court of Auditors, ensuring that funds are used efficiently and effectively. Relations with the Court of Auditors and the appointment of its members constitute another critical area of CONT's responsibilities. The committee considers the Court's reports, which is essential for the transparency and accountability of the Union's financial management.

CONT's competences extend to the realm of anti-fraud activities, working closely with the European Anti-Fraud Office (OLAF). The committee considers cases of fraud and irregularities in budget implementation, measures aimed at preventing and prosecuting such cases, and ensuring the strict protection of the

Union's financial interests. It also oversees actions by the European Public Prosecutor (EPPO) in this field.

CONT is also involved in matters related to the Financial Regulation as far as the implementation, management, and control of the budget are concerned. This ensures that budgetary procedures and practices adhere to the highest standards of financial governance.

Through its comprehensive mandate, the Committee on Budgetary Control plays an indispensable role in overseeing the financial integrity of the European Union, ensuring that its budget is implemented effectively, transparently, well-performing and in the best interest of its citizens.
