Stopping wars fuelled by resources

Exchange of views on "Conflict minerals"

In order to break the link between illegal extraction of minerals, trade and financing of armed conflicts, the Commission has come up with proposals, aiming to contribute to existing instruments such as the American Dodd-Frank Act and the OECD Due Diligence Guidance. The Commission proposes a Union system of self-certification of responsible importers of tin, tantalum, tungsten and gold, which will in time lead to a list of responsible smelters and refiners. Companies that would choose to participate in this voluntary scheme would commit to respect OECD rules set out in due diligence guidance.

INTA MEPs will start their consideration of the proposal this week with a first exchange of views with the Commission. They will consider whether the proposed voluntary system is sufficiently attractive for companies to join in or whether a mandatory system needs to be set up. MEPs will consider arguments on finding a balance between creating an effective system while avoiding excessively cumbersome regulation in order to ensure sufficient supplies of these important minerals, used in production of cars, mobile phones, packaging, construction, aeronautics and jewellery.

Trade preferences for Moldova *Consideration of a draft report*



The EU autonomous trade preferences (ATPs) for Moldova were introduced by the Council Regulation (EC) No 55/2008 of 21 January 2008 ("ATP Regulation"). In recent years the EU and Moldova intensified their political and economic relations notably through the conclusion of an Association Agreement. A trade chapter of the Agreement, signed on 27 June 2014, will lead to the creation of a "Deep and Comprehensive Free Trade Area" (DCFTA) between the Parties. The DCFTA has been

provisionally applied since 1 September 2014.

In the light of deepened EU-Moldova relations, Russia imposed a politically motivated import ban was on agricultural products from Moldova since 21 July 2014, significantly harming Moldova's economy. As an act of solidarity, the Commission proposed to widen existing trade preferences to also cover fresh apples, fresh table grapes and fresh plums, in addition to the tariff rate quotas proposed under the DCFTA. The proposed preferences would provide some benefits and immediate relief to the Moldovan economy, while having very limited impact on the EU market. The additional preferences would apply retroactively from 1 August 2014, in view of the seasonal peak of the three products, but would expire by the end 2015. INTA rapporteur Sorin Moisă (S&D) proposes that the Parliament takes over the Commission proposal without amendments.

Preferential trade with the Western Balkans

Exchange of views

The EU's policy towards the countries of the Western Balkans is defined within the Stabilisation and Association Process launched in May 1999 by the European Commission. Asymmetrical trade liberalisation has been provided for by means of Council Regulation (EC) No 1215/2009 introducing exceptional trade measures for countries and territories participating in or linked to the Stabilisation and Association process.

INTA will exchange views on the Commission proposal amending Regulation (EC) No 1215/2009. There are three main aims of the amendment:

- 1. Prolongation of the current preferences until the end of 2020
- 2. Introduction of the so-called 'human rights' clause'
- 3. Possible suspension of preferences for Bosnia and Herzegovina from 1 January 2016

Stand-still regulation for tariff treatment of goods from Ecuador

Consideration of draft report



INTA will discuss the draft report put forward by the INTA Standing Rapporteur for trade relations with Ecuador, Mr Helmut Scholz, on the Commission proposal on tariff treatment for goods originating from Ecuador. Following the agreement reached by the EU and Ecuador on Ecuador joining the EU-Peru/Colombia Free Trade Agreement (FTA), the Commission has hammered out a proposal to avoid that Ecuador loses its current trade preferences - enjoyed under the GSP+ scheme - before the EU-Ecuador FTA is provisionally applied. The proposal makes the benefits conditional on a

number of elements to be respected by Ecuador such as maintaining ratification and implementation of the GSP+ relevant conventions, engaging in the ratification procedure for joining the EU-Peru/Colombia FTA and abstaining from introducing new duties for imports from the EU. While the rapporteur generally supports the proposal and the Commission approach, he insists that important quasi-legislative decisions - such as to suspend the trade preferences - are not taken without the possibility for the co-legislators - the European Parliament and the Council - to object.

Time to invest in Myanmar?

Public hearing on the EU-Myanmar Investment Agreement




Since 2011 the EU has been demonstrating willingness to support democratic transition in Myanmar by reinstating trade preferences and launching negotiations over an investment agreement. As Myanmar needs foreign investment and European companies need legal certainty; an investment agreement can offer both of them. An EU investment protection agreement is also needed since Myanmar does not have any bilateral investment treaty with any EU Member State. Furthermore, Myanmar's neighbours do not wait: already eight investment agreements have been signed by Myanmar, including with Japan and China. With a large group of experts — including the two negotiators from both sides, INTA Members will analyse the talks, take stock of the political situation in the country and address initial recommendations.

Modernising export controls of the dual-use items

Exchange of views and vote



INTA will debate and vote on a <u>draft oral question</u> to the Commission on the upcoming overhaul of the EU's export control policy. MEPs seek to ensure that the EU-made software and technologies are not diverted from their legitimate use and that the EU's digital infrastructure and strategic interests are duly safeguarded. They urge the Commission to ensure sufficient export controls for surveillance technologies that could be misused for repression and human rights abuses. The full parliamentary debate on the issue is envisaged during the plenary sitting on 26 November.

Fresh look at the EU-Norway trade relations

Exchange of views



Ambassador of Norway to the EU, Atle Leikvoll, will attend a discussion dedicated to the EU-Norway commercial relations. A special attention is expected to be given to the follow-up to the EP resolution of July 2013 on agricultural trade liberalisation and Norwegian agricultural duties. Members will assess the mutual trade relationship in the context of the current Russia's food embargo affecting both sides.

Import rules to be recast - textiles and other goods

Exchange of views



INTA will discuss two proposals to codify existing Regulations that deal with common rules (on surveillance and safeguard measures) for imports. The first proposal covers general import rules and the second one deals with rules on imports of textiles originating in third countries which are not covered by bilateral agreements, protocols or other arrangements, or by other specific EU import rules. Currently, the only countries the EU is importing textiles from that are not covered – General System of

Preferences or Everything But Arms included – are Belarus and North Korea. The regulation allows for the imposition of import restrictions (quotas) on both countries. Both proposals include slight substantive amendments and are, therefore, presented in the form of recasts - a procedure which limits the co-legislators' powers to amend the proposals.

Consent to the EU-Georgia Association Agreement

Consideration of amendments and vote

INTA will consider amendments to and subsequently vote on its opinions for the Committee on Foreign Affairs on the consent recommendation and the accompanying resolution concerning the EU/Moldova Association Agreement, especially its trade-related part – the Deep and Comprehensive Free Trade Area (DCFTA). The Association Agreement signed on 27 June 2014 is provisionally applied since 1 September. The DCFTA represents a core part of the agreement and is one of the most ambitious free trade deals ever negotiated by the EU. It does not only provide for significant liberalization of trade but also for a progressive dismantling of non-tariff barriers. Once fully implemented, the DCFTAs will lead to a genuine and comprehensive economic integration. No amendments were tabled to the draft opinion on the consent recommendation that is in favour of the consent. As for the draft opinion on the accompanying resolution, 21 amendments were tabled.

Trade MEPs take a second look at novel foods

Consideration of amendments, vote



INTA will consider amendments and vote on a draft opinion on a proposed EU Regulation on novel foods. Faced with repeated criticism by third countries at the World Trade Organisation, the Commission proposes introducing a faster and a more proportionate safety assessment for traditional foods from third countries to facilitate their entry on the EU market. INTA rapporteur Jude Kirton-Darling (S&D) is putting forward changes both to the definitions and the procedure for authorising these foods, including on a deeper involvement of the European Food

Safety Authority in the assessment of what constitutes history of safe food use in a third country. INTA Members tabled a total of 109 amendments to the proposal.

INTA to discuss conclusion of the EU-Singapore FTA, the investment chapter Monitoring of trade negotiations



The EU and Singapore have initialled the text of a free trade agreement on 20 September 2013, while negotiations on investment continued. Conclusion of this final chapter marks the end of the FTA negotiations which have started in March 2010. INTA Monitoring group on Singapore has been overseeing the negotiations since 2011.

Members will discuss with the EU Chief Negotiator particularly the outcome of the negotiations on investment, including the

provisions on investor-state dispute settlement. The comprehensive agreement covers market access, tariff and non-tariff barriers, trade facilitation, liberalisation of services, procurement market, investment, sustainable development, IPR including Gls, rules of origin, competition and transparency. INTA Standing Rapporteur for Singapore is Mr David Martin (S&D).

Debate on World Bank's "Doing Business" Report 2015"


INTA will discuss the 12th annual <u>Doing Business Report</u> by the World Bank ranking world's economies in various areas of business regulation. The report will be presented to INTA Members by Mr Augusto Lopez-Claros, Director of Global Indicators and Analysis with the World Bank Group.

Trade MEPs decide on GSP+ trade preferences for the Philippines

Via reduced tariffs for goods, the EU's Generalised System of Preferences (GSP) facilitates access of developing countries' products to the EU market. Additional trade preferences are given to vulnerable developing countries that not only have ratified 27 core international conventions on human rights, environment and good governance, but also commit to improve respect for these conventions.

After the Philippines had submitted a request for GSP+ preferences, the Commission concluded that the country complies with the entry criteria. INTA will now have an exchange of views with the Commission to assess whether the Commission has drawn the right conclusions. Members want to clarify whether granting of GSP+ does not conflict with the Commission's decision to give a yellow card to the Philippines as a warning risking to being identified as a country considered to be non-cooperative in the fight against illegal, unreported and unregulated fishing. If a majority of MEPs would object to the delegated act, the Philippines would not be granted GSP+ preferences.

INTA Standing Rapporteurs for Ecuador, for Vietnam, for the US (TTIP) and for TiSA will report back from discussions with EU chief negotiators (and stakeholders) at respective Monitoring Group meetings. This will allow the entire Committee to be kept in the loop of recent developments in these trade negotiations and to share their views with the Standing Rapporteurs.

EP says yes to Juncker Commission

The Parliament approved the new European Commission led by Jean-Claude Juncker on 22 October, after he presented his college and its working programme for the next five years. As part of European Commission election process, all candidate commissioners had been questioned by MEPs to assess if they were suitable for the job. After an intensive grilling on trade talks with Canada and the USA, investor-to-state dispute settlement and the EU-Ukraine trade agreement, trade MEPs agreed to give green light to the incoming Trade Commissioner Cecilia Malmström. During her hearing, the Commissioner-designate underlined commitment to transparency, expressing willingness to step-up interinstitutional co-operation and dialogue with the civil society.

MEPs extend Ukraine's duty-free access to the EU market



Plans to prolong a largely duty-free access to the EU market for Ukraine's exports until the end of 2015 were backed by the European Parliament on 23 October. Statistical data shows that the exports from Ukraine to the EU in the first half of 2014 have increased by 25%, thereby offsetting the reduction in Ukraine's exports to Russia.

After the 7th round of talks, TTIP negotiating mandate goes public

The 7th round of EU-US negotiations on a Transatlantic Trade and Investment Partnership (TTIP) ending on 3 October has focused on regulatory elements, rules pillar and services. On 9 October, EU governments decided to make the TTIP negotiating mandate public. These TTIP negotiating directives were issued by the Council back in June 2013.

IMF warns of risks for global growth



The International Monetary Fund has cut its forecast for global economic growth in 2014 to 3.3%, lowering the growth projection for 2015 to 3.8%. The Fund says the risks for global recovery stem from uneven and fragile growth (low potential growth in advanced economies and slowing emerging markets), protracted low inflation, financial sector excesses and geopolitical tensions.

Consultations on future of the Bali package, 5th Global Review of Aid for Trade

WTO Director-General Roberto Azevêdo announced on 21 October 2014 the start of consultations on the future of the Bali decisions and the post-Bali work programme. He said that he had heard from WTO members "a willingness to engage in this conversation and to do all we can to find a way forward". Azevêdo also announced that the 5th Global Review of Aid for Trade will be held from 30 June to 2 July 2015. The reviews taking place every two years bring together donors and recipients in order to evaluate the effectiveness of the assistance provided.

STATE-OF-PLAY OF THE UNION'S TRADE DEFENCE INSTRUMENTS (TDI)

EU and China settle the telecoms case at the Joint Committee

Intensive discussions between the European Commission and the Chinese government were concluded by an amicable settlement on the trade defence investigation into Chinese telecoms. The Commission took the official decision that it no longer considers it necessary to pursue this investigation on 20 October. The talks culminated on 18 October at the EU-China Joint Committee, chaired by Commissioner Karel De Gucht and Minister of Commerce Gao Hucheng. EU Trade Commissioner Karel De Gucht said: "I am pleased that the EU and China have resolved the telecoms case. The EU pursues every opportunity to level out the playing field for our companies by engaging with our strategic partners including China. The concerns that have led us to launch the case last May can now be addressed in a systematic and regular dialogue between the two sides for the benefit of our industry." The Financial Times reported that "Under the terms of the truce, European companies should be fully consulted on the development of standards for next-generation technologies in China. The deal will also seek to ensure there is no discrimination in public tenders and that European companies will not be cut out of funding for research in China. Market shares will be monitored and a working group will be set up on limiting companies' access to state export credits." The Wall Street Journal commented the deal saying "The EU insisted on that mechanism to ensure that the three companies get a sizable percentage of huge contracts that are being tendered by China Mobile, the world's largest telecommunications operator by number of customers, to roll out high-speed, fourth-generation broadband across its mobile network. In the first round of China Mobile 4G tenders, concluded last year, European companies received 33% of the business".

On-going investigations

On 30 September 2014, there were 84 anti-dumping and 13 countervailing measures in force. Furthermore, there were undertakings in force from 5 countries covering 6 products. At the end of September, 46 investigations were on-going. 27 investigations were initiated: 11 new investigations, 7 expiry reviews, 4 interim reviews, 2 new exporter reviews, 3 anti-circumvention investigations. As a result of investigations, 1 provisional measure was imposed, involving imports from 1 country and covering 1 product, and 2 definitive measures were imposed involving 1 country and covering 1 product


