1. Constituent meeting

Composition

On 7 July the Committee on International Trade (INTA) held its constituent meeting, electing by acclamation Bernd Lange as its new Chair. The Committee has also elected its vice-chairs: 1st Vice-Chair Tokia Saïfi (EPP), 2nd Vice-Chair Yannick Jadot (Greens), 3rd Vice-Chair Iuliu Winkler (EPP) and 4th Vice-Chair Jan Zahradil (ECR). Together, the chair and vice-chairs make up the Bureau of the Committee, elected for a two-and-a-half year term.

The Committee now is composed of 41 full and 41 substitute members (up from 31 members during the previous 2.5 years). The political composition is as follows.

The political groups have also appointed their new INTA Coordinators: Daniel Caspary (EPP), David Martin (S&D), Emma McClarkin (ECR), Marietje Schaake (ALDE), Helmut Scholz (GUE), William Earl of Dartmouth (EFDD) and Yannick Jadot (Greens).

At the beginning of the first INTA meeting on 22 July, the Coordinators will meet to agree the working methods of INTA during the new parliamentary term.

The 7 July INTA meeting also confirmed the **INTA calendar** for the remainder of 2014.

Responsibilities of INTA

Committee responsible for matters relating to the establishment, implementation and monitoring of the Union's common commercial policy and its external economic relations, in particular:

- 1. financial, economic and trade relations with third countries and regional organisations;
- 2. the common external tariff and trade facilitation as well as the external aspects of customs provisions and management;
- 3. the opening, monitoring, conclusion and follow-up of bilateral, multilateral and plurilateral trade agreements governing economic, trade and investment relations with third countries and regional organisations;
- 4. measures of technical harmonisation or standardisation in fields covered by instruments of international law:
- 5. relations with the relevant international organisations and international fora on trade-related matters, and with organisations promoting regional economic and commercial integration outside the Union;
- 6. relations with the WTO, including its parliamentary dimension.
- 7. The committee liaises with the relevant interparliamentary and ad hoc delegations for the economic and trade aspects of relations with third countries.

forthcoming meeting

The next meeting of the Committee on International Trade is scheduled on Tuesday 22, July 2014, 15.00-16.30 in Brussels. The meeting will be <u>webstreamed</u>, except for the in camera items.

1. General budget of the European Union for the financial year 2015 - all sections

Consideration of draft opinion

INTA will discuss its opinion on the Union's Budget 2015. The discussion will be based on the guidelines on the 2015 budget which the previous INTA committee transmitted to the budget committee in April.

The guidelines recommended that the budget for next year should reflect the fast expansion of the EU's agenda of bilateral trade negotiations (US, Japan, China, ASEAN countries, ACP countries, Mercosur, etc.) and that the budget for trade activities must therefore be shored up in order to ensure that the EU is in a full capacity to negotiate for the EU's interests while keeping up our engagement on all other multilateral, plurilateral and bilateral fronts.

Moreover, INTA then also emphasised the European Neighbourhood Policy should have sufficient budgetary allocation to provide adequate trade-related technical support and assistance to our close partners, and that the instrument for Macro-Financial Assistance has also to be defended.

When promoting the internationalisation and competitiveness of EU SMEs, INTA said it would like the Commission to improve the existing tools in that area. Finally, INTA believed that extra efforts by the Commission are required in the area of monitoring the implementation and the effects of trade agreements negotiated by the EU.

The Committee concluded that the EU would gain by allocating resources to check compliance by third countries with their commitments towards the EU.


