# Weights and dimensions

Rapporteur: Jörg Leichtfried (S&D; AT)
Ordinary legislative procedure, second reading

The new Directive would promote the use of alternative power-trains and aerodynamic flaps and cabs, thus contributing to reductions in CO2 emissions, fuel savings and road safety. The agreement also reduces the administrative burden for use of 45 foot containers in intermodal transport.

Parliament and Council's negotiating teams reached a preliminary agreement on the file on 10 December 2014. The agreed text was presented in Committee today as an amendment to the Council's position.

# Recommendations to the Commission on TTIP negotiations

Rapporteur: Wim van de Camp (EPP; NL) Ordinary legislative procedure, opinion to INTA

The Transatlantic Trade and Investment Partnership (TTIP) remains a high priority across many policy areas. A new Parliament resolution containing recommendations to the Commission is being prepared under the leadership of the International Trade (INTA) Committee. TRAN is one of 13 committees working on an opinion.

The Rapporteur's opinion highlights the restrictions on the transatlantic transport sector still imposed by the US, especially affecting air and maritime transport. There is a lack of reciprocity in access to services, investment restrictions and public procurement.

The debate attracted a lot of interest. The EU lead negotiator for services, Marco Dueerkop, explained how the Commission was pressing for transport issues to be addressed in the negotiations. However, so far, the US side did not appear to be receptive to this.

# Exchange of views with Mr Pedro Ortun, Director DG ENTR, on European Tourism policy

At the first meeting of the re-established Tourism Task Force after the elections, the Commission announced a new set of actions for the promotion of tourism in Europe. The previous ones date from 2010 and were the subject of a comprehensive EP resolution. New actions are

related to: regulatory frameworks for tourism; digitization; professional skills; sustainability; seasonality; interoperability and connectivity; branding Europe; and governance.

Members touched upon issues such as: visa facilitation and security; innovation and fragmentation of the tourism sector; competition among countries and regions; harmonization of standards; peripheral regions; support for SMEs; and budget resources.
