The 33 draft reports concerning the 2013 decentralised agencies discharge were presented by the Rapporteur, Mr Ryszard Czarnecki, to the CONT Committee on 24 February 2015.

Out of the 32 agencies, the Rapporteur is in favour of granting the discharge to 31 agencies and is in favour of postponing the discharge procedure for the European Institute of Innovation and Technology (EIT).

52. PROPOSAL FOR A REGULATION OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL ON THE EUROPEAN FUND FOR STRATEGIC INVESTMENTS AND AMENDING REGULATIONS (EU) NO 1291/2013 AND (EU) NO 1316/2013



The abovementioned proposal creates the necessary legal framework and provides the budgetary allocations to mobilise 315 Billion in additional investment over the next three years and to target initiatives to make sure that this extra investment meets

the need of the real economy.

At the meeting on 10 February 2015 of the Conference of Committee Chairs of the European Parliament, the leading committees ECON and BUDG agreed, in addition to the association of the ITRE and TRAN Committees under Rule 54, to associate under the so-called Rule 53+ those committees whose remit is affected by certain provisions of the proposal and in particular CONT. The reinforced Rule 53 status will permit Rapporteurs of the opinion-giving committees to attend shadows meetings and trilogues in line with the negotiations related to article 14 of the regulation.

The Rapporteur held a meeting with the shadow Rapporteurs on 11 March 2015.

The English version of the draft opinion was circulated to CONT members on 16 March 2014. It focuses on sound financial management and accountability issues and in particular on the mandate of the Court of Auditors.

54.COURT OF AUDITORS SPECIAL REPORTS ON **2013 COMMISSION DISCHARGE**



The 2013 Commission discharge reports were made available all in languages in time for the CONT meeting 23/24 February 2015. The Rapporteur invited the shadow Rapporteurs from the political groups for an in-depth discussion of the

main messages of the discharge report on 25 February.

The Rapporteur is of the opinion that the Parliament cannot politically ensure that the control procedures put in place in the Commission and the Member States give the necessary guarantees concerning the legality and regularity of all underlying transactions in the areas of agricultural policy and rural development, in regional and social policy and also in the area of gross national income contributions. From the Rapporteur's point of view Member States should considerably step-up their vigilance when spending and accounting for European Funds.

The amendments tabled were sent to Members, in the original language version, on 6 March. The translations became available as of 17 March and were put on the <u>committee's website</u>.

Political groups received a first draft voting list (without indications) on 12 March.

The Rapporteur, Ms Dlabajovà, recalled the need for EDFs actions to remain linked closely to the strategic and political priorities and to value for money principles particularly to economic and financial efficiency criteria

and also emphasized the need to better identify activities where most errors and the highest level of vulnerability are.

As regards budget support, the Rapporteur insisted on the strict respect of eligibility conditions linked to the effective progress achieved by recipient countries while ensuring an appropriate policy dialogue and steady monitoring of reforms and programmes achieved by measuring real performance.

On the EIB Investment Facility, the Rapporteur considered the results measurement framework as a useful tool to evaluate not only EIB added value but also to contribute increasing the effectiveness of projects and to ensure consistency with Union priorities.

The cooperation with international organisations is another key domain for which further level of approximation of oversight and governance systems has to be pursued.

Separate chapters are also dedicated to blending activities where Parliament's scrutiny has to be reinforced and to the Union support to Haiti wherein humanitarian and development aid have to be better articulated.

The Committee on Development (DEVE) delivered an opinion on this CONT report on 22 January 2015 for which Ms McAvan was appointed Rapporteur.

63. PROTECTING THE EUROPEAN UNION'S FINANCIAL INTERESTS: TOWARDS PERFORMANCE-BASED CONTROLS OF COMMON AGRICULTURAL POLICY



With the CAP reform farmers should be rewarded for the services they deliver to the wider public such as landscapes, farmland biodiversity, climate stability even though they have no market value.

Therefore a new policy instrument of the first pillar (greening) is directed to the provision of environmental public goods.

As pointed out by the Court of Auditors (opinion 1/2012 on the proposals for regulations to the common agricultural policy for the period 2014-2020) "the arrangements for the common agricultural policy spending continue to be complex. In particular the new framework for cross compliance does not yet correspond to a reduction in the level of complexity of this policy for the managing authorities or for the beneficiaries".

Parliament and the Court of Auditors have often stressed the necessity to strike the right balance between less administrative burden and effective financial control.

In this particular context the European Parliament should favour innovative solutions and could explore the two following approaches:

 Firstly, building on the new role of the certification authorities as defined by the Financial Regulation, the objective would be to put in practice the single audit scheme with only one chain of audits from the final beneficiaries to the European Union institutions.

2. The second way would be to set up a flexible organisation of checks promoting performance-based controls of Common Agricultural Policy.

At the occasion of this second exchange of views CONT has invited different speakers to comment on the subject, in particular Phil Hogan, Member of the European Commission responsible for Agriculture & Rural Development, Kersti Kaljulaid, Member of the European Court of Auditors, Markus Eerola, Vice-President of the board of the Finish Central Union of Agricultural Producers and Forest Owners and a representative of the COPA-COGECA, Pekka Pesonen.
