EU-Vietnam trade talks: MEPs call for substance over speed



With the negotiations for an EU-Vietnam FTA reaching the final ultimate phase, an 8-strong delegation of trade MEPs led by INTA Committee Chairman Mr Bernd Lange visited Hanoi and Ho Chi Minh City on 7-9 April 2015. During the meetings with the Prime Minister Dung, Foreign and Trade Vice-Ministers, the Chairman of the Economic Committee of the National Assembly, and many other counterparts, the INTA Committee members welcomed the commitment of Vietnamese to conclude soon, but underlined that the substance (of talks and quality of the agreement) must prevail over speed. MEPs met the EU business community in Vietnam and held field visits to textiles and automotive industries in Ho Chi Minh City, as well as a meeting with the Chairman of the People's Committee of the city (Mayor of Ho Chi Minh City).

INTA will vote on a record number of amendments to a legislative report tabled in INTA - more than 600 in total. The aim of this key dossier is to set up an EU system for supply chain due diligence in order to provide greater transparency when importers, smelters and refiners source their minerals from conflict-affected or high risk areas. A broad range of amendments were tabled: some seeking to ensure that the system would be mandatory, others to broaden the scope of the regulation beyond trade in tin, tantalum, tungsten and gold and others specifying in more detail

the sort of due diligence that would be applied.

Trade in seal products

Consideration of draft opinion

Members will consider the draft opinion by Mr Bendtsen on the amendment of the regulation 1007/2009 on trade in seal products. The "Seals Regulation" adopted in 2009 set a general ban on the placement of these products on the Union's market, with the exception of the products derived from hunts traditionally conducted by Iniut and other indigenous communities (IC) and the exception of seals hunted for reasons of sustainable management of marine resources (MRM). This legislation was challenged by Canada and Norway in the World Trade Organization. The WTO did not find these exceptions entirely justified. A new regulation to comply with the WTO decision has to be in place by October 2015.

INTA scrutinises animal cloning implications for trade

Consideration of draft opinion



MEPs embark upon regulation of cloning, including the placing on the market of food derived from animal clones and their offspring. Although cloning for farming purposes does not take place in the EU, it is conducted in a few third countries. The draft INTA opinion supports provisional prohibition of imports and placing on the market of animal clones and food derived from clones and their descendants as a measure necessary to protect public morals and animal health. Members aim to

warrant the compatibility of the proposed measures with the WTO framework while ensuring that products derived from clones and their descendants do not enter the EU market. INTA opinion will feed into a legislative report jointly drafted by the ENVI and AGRI committees.

Exchange of views with the Ambassador of China Yang Yanyi

Ambassador of the People's Republic of China to the EU, Mme Yang Yanyi will appear before the INTA Committee. China is the EU's second biggest trading partner and the EU is China's biggest trading partner. The two economic giants trade more than 1 billion euros worth every day. The EU has had a significant trade deficit with China, but at the same time China has been for years the fastest growing market to the EU's exports. The EU and China are currently negotiating a comprehensive investment agreement for better protection of investment and market access. INTA Standing Rapporteur for China is Iuliu Winkler (EPP).

Commission outlines steps for ISDS reform

During the March INTA meeting, Trade Commissioner Cecilia Malmström unveiled preliminary proposals on revamped investment protection and ISDS mechanism in the TTIP and other future FTAs. Proposals go beyond provisions of the EU-Canada trade deal, including an article on the right to regulate.

Trade and investment barriers persist

The EU's strategic economic partners maintain a variety of barriers that significantly hinder international trade and investment opportunities of European companies, concludes the fifth edition of the EU's Trade and Investment Barriers Report (TIBR). Russia tops the list of major obstacles in the EU's priority markets, followed by China, India and Brazil, Argentina and the US. Barriers identified in the report include local sourcing, localisation and data storing requirements, discriminatory taxing, sanitary and food-related barriers and intellectual property rights issues.

STATE-OF-PLAY OF THE UNION'S TRADE DEFENCE INSTRUMENTS (TDI)

On-going investigations and measures in force

Investigations

On 28 February 2015, there were 81 anti-dumping (which were subsequently extended in 26 cases1) and 14 countervailing measures (which were subsequently extended in 1 case1) in force. Furthermore, there were undertakings in force from 4 countries covering 5 products. At the end of February, 38 investigations were on-going.

3 investigations were initiated, out of which 0 new investigations, 1 expiry review, 1 interim review, and 1 other review.

Measures

No provisional measures were imposed; 2 definitive measures were imposed (of which 1 anti-subsidy), involving imports from 2 countries and covering 2 products . 9 reviews were concluded with confirmation of duty.

Terminations

1 new investigation and 1 expiry review was concluded by termination.



<u>Substantive protection under investment treaties a legal and economic analysis</u> [e-book] Jonathan Bonnitcha, Cambridge University Press, 2014, xxx-396 p.

"This book provides the first systematic analysis of the consequences of the substantive protections that investment treaties provide to foreign investors. It proposes a new framework for identifying and evaluating the costs and benefits of differing levels of investment treaty protection, and uses this framework to evaluate the levels of protection for foreign investors implied by different interpretations of the fair and equitable treatment and indirect expropriation provisions of investment."



<u>Making sense of anti-trade sentiment: international trade and the American worker</u> Roger White, Palgrave Macmillan [2014], xiii-258 p.

"Opinion polls indicate that a considerable portion of the U.S. public holds negative views of international trade. The extent of anti-trade sentiment exhibited by the American public is largely out of step with public opinion elsewhere in the world. In fact, the U.S. may be one of the most trade-wary societies. Worries that trade, particularly increased imports, will lead to job loss and/or reduced wages for domestic workers are thought to underlie the negative views."



<u>Services liberalization in the EU and the WTO: concepts, standards and regulatory</u> approaches

Marcus Klamert, Cambridge University Press, 2014, 356 p.

"Both in WTO law and in EU law there is a dichotomy between liberalization based on market access and liberalization targeting domestic regulation. Consequently, both regimes share the problem of distinguishing national measures impairing market access and those that do not have such effect. Moreover, both the EU and the WTO exempt certain categories of 'public' services under partly comparable and complex conditions. Specific to EU law are the legal issues that have arisen because of the recent adoption of the Services Directive, which has both amended EU services law and has led to a fragmentation of the rules applicable to different service sectors in the EU. A final chapter discusses possible approaches to regulation such as home state rule, host state rule and mutual recognition from a comparative perspective."
