A WORD FROM THE CHAIR



The highlight of this week's committee meeting is the Structured Dialogue with Vice-President of the Commission, Andrus Ansip. This will be a very timely opportunity for the

presentation of the Commission's Digital Single Market strategy, due to be published the same day. The digital economy is expanding at an incredible pace, but its growth is held back by fragmentation and barriers, and this needs to be tackled urgently. The remedy is a genuine Digital Union of which a digital single market is a crucial pillar. Our committee's objective is also to see Europe regain its status as world leader in ICT, not least by reforming rules applying to the telecoms sector, which is the backbone of the digital economy and society.

Another important item on the agenda of this ITRE session will be the debate on the future of the Energy Community which connects the EU with 8 of its neighbouring countries to the South and the East. Last year the High-level Reflection Group issued a strategy for the years 2016 - 2026 on how the Energy Community's work can be improved. Following a presentation by Janez Kopač, Director of the Energy Community Secretariat, we will hold an exchange of views with parliamentarians all Contracting Parties Community. I am sure the debate will fit very well in the framework of our broader discussions on the Energy Union and pan-European energy security.





Structured Dialogue with Andrus Ansip, Vice-President for Digital Single Market



On 6 May ITRE Committee will welcome Vice-President Ansip, responsible for the Digital Single Market, within the context of the "Structured Dialogue" between European Parliament and the Commission. Mr Ansip will present and hold and exchange of views with ITRE Members on the Digital Single Market strategy, which is due to be published that very day. The strategy will set out the Commission's approach on how the EU should seize the opportunities and address the challenges brought by the digital revolution.

The work of the European Network for Transmission System Operators (ENTSO) in the context of the Energy Union

The European Networks of Transmission System Operators for Electricity (ENTSO-E) and gas (ENTSO-G) will present their ongoing work to the Committee.

Special emphasis will be placed on aspects of their mandates which relate to security of supply issues and which are of political relevance for the current discussions in the context of the Energy Union.

The presentation will be followed by a debate with Members.

Energy Community - presentation of activities

Mr Janez KOPAČ, Director of the Energy Community Secretariat, will present the ongoing work of the Energy Community, which was established in 2005 with a view to extending the EU internal energy market to South East Europe and beyond on the basis of a legally binding framework.

This will be followed by a debate with Members on the progress made so far by the Energy Community and its future role in contributing to EU energy policy objectives in light of the current challenges.

TTIP negotiations (Transatlantic Trade and Investment Partnership)

European Commission will brief the ITRE Committee on the ninth round of EU-US trade talks that took place in New York on 20-24 April 2015.

The transatlantic trade and investment partnership (TTIP) is a free trade agreement currently being negotiated between the European Union and the United States.

ITRE Committee voted on the opinion on the European Parliament's

recommendations to the European Commission on the negotiations for the Transatlantic Trade and Investment Partnership (TTIP) on 24 March 2015. The lead committee, INTA, aims to vote on these recommendations on 28 May 2015 and this report is foreseen in the plenary in June 2015.

The next formal TTIP negotiation round is foreseen in July 2015 in Brussels.

Debfriefing from ITRE mission to BEREC and BEREC Office in Riga, Latvia



The ITRE mission to the Body of European Regulators for Electronic Communications (BEREC) and BEREC Office took place on 7-8 April 2015.

The BEREC Office is an agency which ITRE is responsible for, so every two years a delegation is sent to discuss their work and issues of importance in the telecoms sector.

Discussions with the BEREC Chair, BEREC Office and Latvian MPs focussed on pressing current telecoms issues such as roaming and net neutrality, and future challenges in the telecoms sector.

Debfriefing from ITRE mission to BEREC Office mission to Washington DC and Pennsylvania, USA

ITRE mission to Washington, DC and Pennsylvania took place on 16-19 March 2015. One of the aims of the ITRE mission was to study the shale gas phenomenon in Pennsylvania, where much of the rapid growth in shale gas production has occurred. In Washington, DC the delegation met among others with representatives of the Department of Energy and Federal Communications Commission as well as with relevant Congressmen.
