Background and purpose of the hearing

Regulation (EC) No 810/2009 of the European Parliament and of the Council of 13 July 2009 establishing a Community Code on Visas (Visa Code) contains the conditions and procedures for the issuing of Schengen short-stay visas. As such it is one of the core elements of the EU's common visa policy. Other elements of this visa policy are the Regulation 539/01 containing the lists of countries whose citizen require a visa to enter the Schengen area and those exempt from the visa obligation, the Visa Information System, the provisions on the uniform visa and a range of visa facilitation agreements with third countries.

In April 2014, just before the end of the last parliamentary term, the European Commission presented its visa package. It consists mainly of two legislative proposals, namely the proposal for a Regulation on the **Union Code on Visas** (COM(2014) 0164) amending the Visa Code currently in force and the proposal for a Regulation establishing a **touring visa** (COM(2014) 0163), a completely new type of visa. The package also contains a report about the implementation of the current Visa Code in force as required by it (COM(2014) 0165) which is accompanied by a more detailed staff working document (SWD(2014) 0101).¹

The Committee on Civil Liberties, Justice and Home Affairs started the examination of these proposals at the beginning of the new legislative term. Following a series of informal meetings with the Commission's services two working documents were presented by the two rapporteurs in the Committee on 5 March. At the same meeting the study requested by the Committee on humanitarian visas was presented.

With this hearing the Committee seeks the input of experts for its further works. As the proposals have a significant impact on the work of consulates but also on visa applicants as well as on EU citizens - be it as business partners, family members or others - it is crucial to hear from as many concerned parties as possible in order to formulate an adequate response of the Committee to the Commission's proposals. The hearing therefore complements the mission to Istanbul with a series of visits to consulates as well as an external service provider which took place on 9-10 April this year.

SESSION II - The proposal for the new Touring Visa

The touring visa is a new type of visa which would permit the future holder to travel within the Schengen Area for a total of more than 90 days in any 180-day period, provided that he does not stay in the same Member State for more than 90 days. The visa would be valid for one year, and be renewed for an additional year, extending its total period of validity to a maximum of two years.

During this hearing and following the rapporteur's introduction, the speakers' views will be sought on the following questions:

- What would be the relevance of the touring visa?
- What do you think of the potential economic impact?
- What do you think of the security and migratory risks?
- Do you think the scope should be narrowed or extended regarding above considerations?
