Meeting highlights (21-22/09/2015)

Commission unveils investment protection reform

Deputy Director General of DG Trade, Mr Mauro Petriccione, will present to Members the EU proposal on investment protection in the EU-US Transatlantic Trade and Investment Partnership (TTIP) negotiations. Responding to the demands of the Parliament on the reform of the investor-to-state dispute settlement (ISDS) mechanism, the Commission has unveiled a new system for resolving disputes between investors and states. The new Investment Court System would replace the existing ISDS system in TTIP and other current and future EU negotiations on investment. Within the public Investment Court System, the claims will be examined by the Tribunal and the appeals will be heard by a new Appeal Tribunal, operating on similar principles to the WTO Appellate Body. A modernised transparent system would balance the governments' right to regulate with clearly delimited rights of investors to contest discrimination. The Parliament has called for a transparent dispute resolution mechanism in its 8 July recommendations for the TTIP negotiations.

Anti-Torture Regulation: halting trade in inhumane equipment

Vote on the draft report



INTA will vote on a revamped "Anti-Torture Regulation", aiming to step-up the EU-wide controls on trade in items that could be misused for capital punishment, torture, inhuman or degrading treatment. Members seek to enhance the oversight of transit, promotion and other ancillary services. They want to strengthen controls by including a "catch-all" clause for non-listed items and by boosting co-ordination between authorities. To become a law, the amendment needs to be agreed upon by the EP and the Council.

INTA continues dialogue with OECD

Exchange of views

INTA MEPs will hold an exchange of views with Mari Kiviniemi, Deputy Secretary-General of the Organisation for Economic Co-operation and Development (OECD). Mr Kiviniemi will present the OECD's estimates on world trade and key economic developments and the challenges that come along. The OECD is one of the most important global standard-setter in world trade and plays a crucial role in areas such as the developing of specific guidance on due diligence, trade liberalisation and export credits.

"Safety valves" in case of surging imports from Moldova and Georgia Joint debate



INTA will discuss proposals for Regulations aimed at implementing the trade parts (DCFTAs) of the Association Agreements between the EU and two of its Eastern partners, Moldova and Georgia. The first proposal concerns the incorporation into the EU law of the safeguard clause and the anti-circumvention mechanism foreseen in the EU-Moldova Agreement. The second one aims to incorporate into the EU legislation the anti-circumvention rules foreseen in the EU-

Georgia Association Agreement. Both are largely based on comparable regulations agreed by the colegislators for some of the EU's recent FTAs, namely with South Korea, Central America, Colombia and Peru.

Progress in Bangladesh Sustainability Compact

Exchange of views with stakeholders

INTA continues scrutinising implementation of the "Sustainability Compact" in Bangladesh. In place since July 2013, the initiative by the EU Commission, ILO and the Bangladeshi government aims to improve labour rights and working conditions in the Bangladeshi ready-made garment industry - a sector, which has been given tremendous boost by unilateral duty-free access to the EU market under the EU's "Everything, but Arms" initiative. In January 2015 INTA discussed the state of play with the Ambassador of Bangladesh to the EU. A follow-up exchange of views will be held with local and European businesses based in Bangladesh as well as representatives from the trade unions and the ILO. INTA closely follows implementation of trade agreements and associated initiatives aimed at improving living conditions through trade.

Opening of negotiations for an EU-Tunisia Free Trade Agreement *Exchange of views*

On 27 May, Tunisia announced its readiness to engage into negotiations for a deep and comprehensive free trade agreement with the EU. The first negotiating round is planned for mid-October in Tunisia. Therefore it is timely that INTA Committee holds an exchange of views with the Tunisian Ambassador and the Commission (DG Trade) on the priorities and wishes of Tunisia regarding these negotiations. In addition, INTA Committee will adopt a resolution on the topic later in the year.

Annual Report of European Investment Bank (EIB)

First exchange of views

On a yearly basis, the EIB presents a report on its activities of the previous years. Apart from its contribution to the internal EU policies, the EIB has also a mandate to support EU action in third countries. It is the first annual report during the current EIB mandate that began in 2014 and will last until 2020. EIB's external activities have to be aligned with the EU external policy and actions. In order to fulfil its external mandate it operates a budget of 27 billion € that may be increased by additional 3 billion if agreed by the European Parliament and the Council.

Implementation of the EU's macro-financial assistance

Exchange of views

The Commission's report on the implementation of macro-financial assistance to third countries in 2014 focuses on programmes in Ukraine, Georgia, Tunisia, Jordan and the Kyrgyz Republic. The total amount of outstanding MFA loans was EUR 1,842 million at year-end 2014. This sum is guaranteed by the EU budget. MFA loan disbursements are expected to reach close to EUR 1.9 billion in 2015. These figures do not, however, take account of possible new MFA operations for which the Commission has not yet presented a proposal. Given the considerable amount of outstanding MFA loans, INTA MEPs will discuss the latest MFA-implementation report two days ahead of the INTA delegation visit to Ukraine.

"The EU's Trade Policy: from gender-blind to gender-sensitive?" Presentation of a study

The trade policy can have differing gender impact across the various sectors of the economy. The study aims to provide a background for policy makers to better understand the gender dimension of trade agreements in order to ensure that both women and men can reap the benefits of trade liberalisation and be protected from its negative effects. The study was prepared upon the initiative of the INTA Members responsible for Gender mainstreaming, namely Ms Tokia Saïfi (EPP), Ms Inmaculada Rodriguez-Pinero (S&D) and Ms Eleonora Forenza (GUE).

The EU on track to ratify the Trade Facilitation Agreement

On 9 September the European Parliament has given its consent to the WTO's Trade Facilitation Agreement (TFA), thus enabling the Council complete ratification procedure on behalf of the EU ahead of the 10th WTO Ministerial Conference (MC10) in Nairobi in December 2015. The EU and its members would follow suit of 16th WTO members that formally accepted the TFA, including China, Hong Kong, Singapore, the United States, Mauritius, Malaysia, Japan, Australia, Botswana, Trinidad and Tobago, the Republic of Korea, Nicaragua, Niger, Belize, Switzerland and Chinese Taipei. The TFA, which seek to modern customs procedures in order to stimulate international trade, will enter into force once two-thirds (107 members) of the signatories have formally endorsed the Agreement.

STATE-OF-PLAY OF THE UNION'S TRADE DEFENCE INSTRUMENTS (TDI)

On-going investigations and measures in force

On 31 August 2015, there were 81 anti-dumping (which were subsequently extended in 29 cases) and 14 countervailing measures (which were subsequently extended in 1 case) in force. Furthermore, there were undertakings in force from 4 countries covering 5 products. At the end of August, 46 investigations were on-going.

New investigations initiated until 31 August 2015

25 investigations were initiated:

- 8 new investigations, of which 2 anti-subsidy
- 5 expiry reviews
- 5 interim reviews, of which 2 anti-subsidy
- 1 other review
- 6 anti-circumvention investigations

9 provisional measures were imposed, involving imports from 6 countries and covering 4 products; 4 definitive measures were imposed (of which 1 anti-subsidy), involving imports from 4 countries and covering 3 products. 16 reviews were concluded with confirmation of duty. 1 anti-absorption investigation was concluded with increase of duty and 3 anti-circumvention investigations were concluded with extension of duty. 2 new investigations and 3 reviews were terminated without the imposition of measures.

RECENT WTO DISPUTE SETTLEMENT DEVELOPMENTS

Latest DSU developments as of 15 September 2015

At present, the EU is actively involved in 47 WTO disputes: in 23 of these cases the EU is the complaining party while in the remaining 24 cases the EU is on the defending side. These cases relate to the EU's relations with 11 of its trading partners (Argentina, Brazil, Canada, China, India, Indonesia, Norway, Pakistan, Philippines, Russia, Thailand and the US).

Dispute settlement activities against the US continue to represent the majority of EU's active disputes. The EU is the complaining party in 6 of the disputes and the defendant in 5 cases (GMOs, hormones, bananas, poultry and aircraft). Regarding the substance of EU's offensive cases with the US, a major part concerns the misuse of trade defence instruments.

The EU's cases with China concern services, anti-dumping measures and raw materials on the offensive side and antidumping, poultry tariff and feed-in-tariff measures on the defensive side.






