On 30 September 2015 the European Parliament received in all the official languages the Commission Delegated Regulation (EU) .../.. of 30 September 2015 amending Commission Delegated Regulation (EU) 2015/35 concerning the calculation of regulatory capital requirements for several categories of assets held by insurance and reinsurance undertakings (C(2015) 6588).

Pursuant to Article 301a of Directive 2009/138/EU of the European Parliament and of the Council of 25 November 2009 on the taking-up and pursuit of the business of Insurance and Reinsurance (Solvency II) (recast) and Article 290(2)(b) of the Treaty on the Functioning of the European Union, I hereby inform you, in line with Rule 105 of Rules of Procedure of the European Parliament, that the deadline for raising objections to the delegated act in question is extended by three months, i.e. until 30 March 2016.
