# Introductory words by Thomas Händel



The EMPL committee carries on with its agenda in 2016, with three committee meetings taking place this month. The first meeting of the year took place on 11 January, when we had the opportunity to hear Lodewijk Asscher, Dutch Deputy Prime Minister and Minister of Social Affairs and Employment, presenting the programme of the Dutch Presidency in the field of employment and social

affairs, including most importantly the targeted revision of the Posting of Workers Directive, the launching of the Labour Mobility Package and initiatives to expand workers' protection from carcinogens. On the same meeting the Rapporteurs presented their draft reports on the European Semester and the application of the Parental Leave Directive.

The committee meets for the second time this month on 25 January, when we will discuss the draft report on social dumping, in which the Rapporteur makes a number of recommendations in key areas to address the phenomenon of social dumping. At the same meeting we will also discuss an oral question to the Commission on the creation of a Europe with a Triple A Social Rating' as proposed by President Juncker.

The third meeting, on 26 January will be dedicated to a discussion with Pier Carlo Padoan, Italian Minister of Economy and Finance, where he will present his proposal for a European Unemployment insurance scheme. This topic has been subject of several debates in Brussels for a while and now it will be interesting to hear it from a different angle, specifically from a Minister of a Member State.

Finally I would like to wish all the readers a happy and successful year and I hope that your respectable attention towards the work of the EMPL committee will continue throughout the year.

# The Netherlands Presidency – Lodewijk Asscher, Deputy Prime Minister and Minister of Social Affairs and Employment

# **Exchange of views**



On 11 January the committee held an exchange of views with Dutch deputy Prime Minister and Minister of social affairs and employment, Lodewijk Asscher, about the Dutch Council Presidency programme in the field of employment and social affairs. The Minister explained that a targeted

revision of the Posting of Workers Directive aimed at the same pay for the same work in the same place of work would be a main priority and he urged the Commission to launch the broader Labour Mobility Package, of which the targeted review will be part, as soon as possible. The Minister also told the committee that combating work-related cancer by expanding workers' protection against a wider range of carcinogens, by amending the carcinogens Directive, and that strategies on poverty reduction would be two further Dutch Presidency priorities. # European unemployment insurance scheme – proposal presented by Minister Pier Carlo Padoan

# **Exchange of views**

On 6 October 2015 the Italian Ministry of Economy and Finance released a paper proposing the set-up of a European unemployment insurance scheme; on the same day, Minister Padoan presented the initiative on the occasion of a lecture at the University of Luxembourg. EMPL committee invited the Minister to present his proposal and discuss it with the Members of the committee on 26 January. The proposal argues that measures to address the social cost of the crisis and enhance citizens' trust in the EU are needed. Adjustments, notably in the labour market, could greatly benefit from a common cyclical unemployment support that would amplify positive spill overs, impact and effectiveness of reforms. In addition, a positive signal on the irreversibility of the common currency would contribute to macroeconomic stability and anchor positive expectations.

# European Semester for economic policy coordination: Employment and Social Aspects in the Annual Growth Survey 2016

# Consideration of draft report and amendments

The Rapporteur presented her draft report on 11 January. The Rapporteur highlighted the importance of the social pillar in the European Semester and expressed that greater efforts and structural investments were necessary to reach convergence in the EU. She highlighted that long-term unemployment should be addressed in a new way, paying attention to the individual circumstances and needs. the presentation, Members praised Following Rapporteur's text and added that the final report should also address pension reforms, minimum wage and more attention should be paid to the recommendations for the euro area. On 25 January, EMPL will discuss the 430 amendments tabled to the draft report in view of the vote on 17 February.

# Application of Council Directive implementing the revised Framework Agreement on parental leave

# **Consideration of draft report**



The committee organised a discussion with stakeholders in November on the parental leave Directive, which discussion served as an input to the draft report, which

presented in EMPL on 11 January. In her presentation the Rapporteur regretted that in the context of the recently published work-life balance roadmap, the Commission failed to publish a report on the implementation of the parental leave Directive. She also stressed that improved coordination, coherence and accessibility in the Member States' leave systems (maternity, paternity and parental) increases participation levels and overall efficiency. In the discussion,

Members mentioned issues such as the large differences existing between Member States, the need to have clear definitions, the importance of transferability to ensure work life balance and gender equality, as well as the meaning of parental 'leave' vs. parental 'work'. The deadline for amendments was set for 14 January in view of the vote in committee in March.

# Social dumping in the European Union Consideration of draft report



In his draft report the Rapporteur makes a number of recommendations in key areas such as reinforcing controls and coordination between Member States, addressing

regulatory gaps in order to implement the principle of 'equal pay and equal social protection for the same work' and moving towards social convergence. Among other suggestions, the draft report calls on the Commission to submit a proposal for a directive on labour inspection and on Member States to increase the staffing levels and resources of their labour inspectorates and their liaison offices, including the creation of a European body of cross-border labour inspectors. The draft report also includes a section on mobile workers, stressing the need to combating social dumping in the transport industry. The draft report will be discussed in committee on 25 January.

# European Centre for the Development of Vocational Training (Cedefop)

Maximising skills for jobs and jobs for skills in the era of the robots – More than 130 experts and representatives of governments, social partners, education and training, and the labour market discussed how technology and workplace change impact on skill needs and how to create partnerships to address skill mismatch at Cedefop's high-level conference in Thessaloniki on 7 and 8 December. Findings of Cedefop's European skills and jobs (ESJ) survey, were also discussed at the conference, which featured some world-renowned speakers. More.

# European Foundation for the Improvement of Living and Working Conditions (Eurofound)

Social dimension of intra-EU mobility: Impact on public services – Freedom of movement across Member States is one of the core values of the European Union and is closely linked to European citizenship. There is, however, a heated debate in many of the host Member States about the impact of the rising inflow of mobile citizens on their public services.
