The Rapporteur together with the Shadow Rapporteurs consolidated and finalised the questionnaire and submitted it to the Secretary-General on 25 November 2015.

The Secretary-General's written replies were received and made available to Members on 19 January 2016.

4. IMPROVING THE FUNCTIONING OF THE EUROPEAN UNION BUILDING ON THE POTENTIAL OF THE LISBON TREATY



Consideration of draft opinion.

Rapporteur: <u>Petri Sarvamaa</u> (PPE) Administrator: Mauro de Oliveira

CONT committee is providing an opinion to the Constitutional Affairs Committee (AFCO) on its initiative report: Improving the functioning of the European Union building on the potential of the Lisbon Treaty.

Elmar Brok and Mercedes Bresso are the (AFCO) Rapporteurs.

Mr Sarvamaa points out that the Institutions of the Union and the Member States should cooperate fully in order to maximise the potential of the Lisbon Treaty when it comes to implementing and effectively protecting the budget of the European Union.



He considers fundamental to observe budgetary discipline and use available EU funds efficiently and effectively and notes that the existing Structural Funds should be used more effectively to foster competitiveness and social cohesion, with stringent supervision of their proper implementation.

The Rapporteur recalls that despite some progress, the evaluation report as provided for in Article 318 TFEU is not yet a useful contribution to the evidence available when Parliament, in its power as discharge authority, grants discharge to the Commission.

He considers also that effective supervision of the Union's budget implementation requires cooperation between Parliament, the European Council and the Council in order to enhance the transparency of financial management and improve democratic accountability towards EU taxpayers. The sustained lack of cooperation by the Council has a persistent negative effect on citizens' perceptions on the credibility of the EU institutions.

Mr Sarvamaa recommends that the European Court of Auditors be strengthened and expects the Court to remain committed to independence, integrity and impartiality. The Rapporteur calls for closer cooperation between the Court and national supreme audit institutions and considers that the Parliament and the Council should be on an equal footing when appointing Members of the Court of Auditors.
