# 3. WORKSHOP ON JOINT UNDERTAKINGS DISCHARGE: SUCCESS STORIES AND DIFFICULTIES SEEN FROM THE BENEFICIARIES' PERSPECTIVE

The rapporteur considers that the perspective of the beneficiaries of the Joint Undertakings is not given prominence during the annual discharge procedure. Often their views are not taken duly into consideration when discussing the issues of budgetary and financial management. In order to sufficiently take into account the opinion of the beneficiaries, the rapporteur would like to gain first hand insight into their practical experience with EU funding. Consequently he would like to go beyond

the formal discharge procedure, and hear the beneficiaries how they use the funds allocated to them and what are the success stories, what difficulties are they encountering when implementing the projects. The Parliament's review of spending should not stop at checking the documents and reports received, but should also include a direct exchange of view with the beneficiaries.



Beneficiaries will be expected to address issues such as the types of grants, eligibility conditions and ineligible costs, rights and obligations of beneficiaries, use of in-kind contributions, implementation of action tasks by subcontractors, submission of deliverables, reporting, checks, reviews, audits, dissemination and communication of results, visibility of support, and ownership of results.
