Subject:	Discharge to be given to the joint undertakings in respect of the implementation of the budget for the financial year 2014
	– <i>Draft Council recommendations</i>

1. In accordance with the relevant establishing acts and, as for the European Joint Undertaking for ITER and the Development of Fusion Energy and the SESAR Joint Undertaking, also in accordance with Article 208(2) of Regulation (EU, Euratom) No 966/2012<sup>1</sup>, the Council is required to draw up recommendations to the European Parliament on a discharge to be given to the joint undertakings.

2. At its meetings on 7 and 27 January 2016, the Budget Committee examined the eight specific annual reports<sup>1</sup> of the European Court of Auditors related to joint undertakings, and reached an agreement on the draft texts as set out in the Addendum.
3. The Budget Committee advises the Permanent Representatives Committee to suggest that the Council:
  - adopt the draft recommendations as set out in the Addendum to this note; and
  - arrange for them to be forwarded to the European Parliament and to approve the draft letter in the Annex to that effect.
