

At the sitting of 18 January 2000 Parliament adopted its position at first reading on the proposal with a view to the adoption of a Directive of the European Parliament and of the Council amending Council Directive 94/55/EC on the approximation of the laws of the Member States with regard to the transport of dangerous goods by road (COM(1999) 158 - 1999/0083 (COD)).

At the sitting of 6 July 2000 the President of Parliament announced that the common position had been received and referred to the Committee on Regional Policy, Transport and Tourism (7455/1/00 - C5-0330/2000).

The committee had appointed Dieter-Lebrecht Koch rapporteur at its meeting of 31 August 1999.


It considered the common position and the draft recommendation for second reading at its meetings of 12 September 2000 .

At the latter meeting it adopted the draft legislative resolution unanimously.

DRAFT LEGISLATIVE RESOLUTION

European Parliament legislative resolution on the Council common position with a view to the adoption of a Directive of the European Parliament and of the Council amending Council Directive 94/55/EC on the approximation of the laws of the Member States with regard to the transport of dangerous goods by road (7455/1/00 – C5-0330/2000 – 1999/0083(COD))

(Codecision procedure: second reading)

The European Parliament,

- having regard to the Council common position (7455/1/00 C5-0330/2000),
- having regard to its position at first reading¹ on the Commission proposal to Parliament and the Council (COM(1999)158²),
- having regard to the Commission's amended proposal (COM(2000) 185³),
- having regard to Article 251(2) of the EC Treaty,
- having regard to Rule 78 of its Rules of Procedure,
- having regard to the recommendation for second reading of the Committee on Regional Policy, Transport and Tourism (A5-0234/2000),
- 1. Approves the common position;
- 2. Notes that the act is adopted in accordance with the common position;
- 3. Instructs its President to sign the act with the President of the Council pursuant to Article 254(1) of the EC Treaty;
- 4. Instructs its Secretary-General duly to sign the act and, in agreement with the Secretary-General of the Council, to have it published in the Official Journal of the European Communities;
- 5. Instructs its President to forward its position to the Council and Commission.
