At the sitting of 7 September 2000 Parliament adopted its position at first reading on the proposal for a Directive of the European Parliament and of the Council amending for the nineteenth time Council Directive 76/769/EEC relating to restrictions on the marketing and use of certain dangerous substances and preparations (azocolourants) (COM(1999) 620 - 1999/0269 (COD)).

At the sitting of 28 February 2002 the President of Parliament announced that the common position had been received and referred to the Committee on the Environment, Public Health and Consumer Policy (15079/1/01 - C5-0071/2002).

The committee had appointed Emmanouil Bakopoulos rapporteur at its meeting of 26 January 2000.

It considered the common position and draft recommendation for second reading at its meetings of 16 April and 23 May 2002.

At the latter meeting it adopted the draft legislative resolution by 38 votes to 0, with 3 abstentions and decided to apply the procedure without debate laid down in Rule 114(1) of the Rules of Procedure.

DRAFT LEGISLATIVE RESOLUTION

European Parliament legislative resolution on the Council common position with a view to the adoption of a Directive of the European Parliament and of the Council amending for the nineteenth time Council Directive 76/769/EEC relating to restrictions on the marketing and use of certain dangerous substances and preparations (azocolourants) (15079/1/01 – C5-0071/2002 – 1999/0269(COD))

(Codecision procedure: second reading)

The European Parliament,

- having regard to the Council common position (15079/1/01 – C5-0071/2002),
 - having regard to its position at first reading¹ on the Commission proposal to Parliament and the Council (COM(1999) 620²),
 - having regard to the amended Commission proposal (COM(2000) 785)³
 - having regard to Article 251(2) of the EC Treaty,
 - having regard to Rule 78 of its Rules of Procedure,
 - having regard to the recommendation for second reading of the Committee on the Environment, Public Health and Consumer Policy (A5-0194/2002),
1. Approves the common position;
 2. Notes that the act is adopted in accordance with the common position;
 3. Instructs its President to sign the act with the President of the Council pursuant to Article 254(1) of the EC Treaty;
 4. Instructs its Secretary-General duly to sign the act and, in agreement with the Secretary-General of the Council, to have it published in the Official Journal of the European Communities;
 5. Instructs its President to forward its position to the Council and Commission.
