By letter of 31 October 2002 the Council consulted Parliament, pursuant to Article 170 (2), in conjunction with Article 300 (2), first subparagraph, and Article 300 (3), first subparagraph of the EC Treaty on the proposal for a Council decision concerning the conclusion of the Agreement for scientific and technological cooperation between the European Community and Ukraine (COM(2002) 550 - 2002/0243 (CNS)).

At the sitting of 7 November 2002 the President of Parliament announced that he had referred this proposal to the Committee on Industry, External Trade, Research and Energy as the committee responsible (C5-0516/2002).

At its meeting of 26 November 2002 on a proposal from the Chairman, the Committee on Industry, External Trade, Research and Energy decided to approve the proposal without amendment under Rule 158 (1), thus appointing its chairman rapporteur.

DRAFT LEGISLATIVE RESOLUTION

European Parliament legislative resolution on the proposal for a Council decision concerning the conclusion of the Agreement for scientific and technological cooperation between the European Community and Ukraine (COM(2002) 550 – C5-0516/2002 – 2002/0243(CNS))

(Consultation procedure)

The European Parliament,

- having regard to the Commission proposal to the Council (COM(2002) 550¹),
 - having regard to Articles 170 (2), and Article 300 (2), first subparagraph, of the EC Treaty,
 - having been consulted by the Council pursuant to Article 300 (3), first subparagraph, of the EC Treaty (C5-0516/2002),
 - having regard to Rule 67, Rule 97 (7) and Rule 158 (1) of its Rules of Procedure,
 - having regard to the report of the Committee on Industry, External Trade, Research and Energy (A5-0412/2002),
1. Approves the conclusion Agreement;
 2. Instructs its President to forward its position to the Council and Commission and the governments and parliaments of the Member States and Ukraine.
