At the sitting of 11 June 2002, Parliament adopted its position at first reading on the proposal for a regulation of the European Parliament and of the Council amending Council Regulation (EEC) No 95/93 of 18 January 1993 on common rules for the allocation of slots at Community airports (COM(2001) 335 – 2001/0140(COD)).

By letter of 8 November 2002 the Commission submitted to Parliament, pursuant to Article 251(2) and Article 80(2) of the EC Treaty, the amended proposal for a regulation of the European Parliament and of the Council amending Council Regulation (EEC) No 95/93 of 18 January 1993 on common rules for the allocation of slots at Community airports (COM(2002) 623 – 2001/0140(COD)).

By letter of 24 April 2003 the Commission submitted to Parliament, pursuant to Article 251(2) and Article 80(2) of the EC Treaty, the proposal for a regulation of the European Parliament and of the Council amending the amended proposal for a regulation of the European Parliament and of the Council amending Council Regulation (EEC) No 95/93 of 18 January 1993 on common rules for the allocation of slots at Community airports (COM(2003) 207 – 2001/0140(COD)).

At the sittings of 18 November 2002 and 15 May 2003 the President of Parliament announced that he had referred these proposals to the Committee on Regional Policy, Transport and Tourism as the committee responsible and the Committee on Economic and Monetary Affairs for its opinion (C5-0530/2002 and C5-0186/2003).

At the request of the Committee on Regional Policy, Transport and Tourism, the President of Parliament informed the Commission by letter of 11 June 2003 that Parliament considered that the submission on 24 April 2003 of the proposal for a regulation of the European Parliament and of the Council amending the Commission's amended proposal constituted a renewed referral to Parliament under Rule 71(1), second indent, of Parliament's Rules of Procedure, and that the committee responsible would consider the proposal in accordance with the procedures laid down for a first reading.

At its meeting of 12 June 2003, the Committee on Regional Policy, Transport and Tourism decided, on a proposal from the chairman, to apply the simplified procedure under Rule 158(1) of the Rules of Procedure, as a result of which the chairman of the committee was appointed rapporteur.

DRAFT EUROPEAN PARLIAMENT LEGISLATIVE RESOLUTION

on the proposal for a regulation of the European Parliament and of the Council amending the amended proposal for a regulation of the European Parliament and of the Council amending Council Regulation (EEC) No 95/93 of 18 January 1993 on common rules for the allocation of slots at Community airports (COM(2003) 207 – C5-0186/2003 – 2001/0140(COD))

(Codecision procedure: first reading – renewed referral)

The European Parliament,

- having regard to the proposal amending the amended Commission proposal to the European Parliament and the Council (COM(2003) 2071),
- having regard to the amended Commission proposal to the European Parliament and the Council (COM(2002) 623²),
- having regard to the Commission proposal to the European Parliament and the Council (COM(2001) 335³),
- having regard to the position it adopted at first reading on 11 June 2002⁴,
- having regard to Article 251(2) and Article 80(2) of the EC Treaty, pursuant to which the Commission submitted the proposal to Parliament (C5-0186/2003),
- having regard to Rules 67, 71(1) and 158(1) of its Rules of Procedure,
- having regard to the report of the Committee on Regional Policy, Transport and Tourism (A5-0222/2003),
- 1. Approves the Commission proposal as a proposal in its own right;
- 2. Asks the Commission and the Council to deal with the amendments to Regulation (EEC) No 95/93 on common rules for the allocation of slots at Community airports and with those contained in the proposal amending the amended proposal in two separate regulations;
- 3. Asks for the matter to be referred to it again, should the Commission intend to amend its proposal substantially or replace it with another text;
