<p>(19) Flexibility is appropriate to enable the continued use of traditional methods at any of the stages of production, processing or distribution of food and in relation to structural requirements for establishments. Flexibility is particularly important for regions that are subject to special geographical constraints, including the outermost regions referred to in Article 299(2) of the Treaty. However, flexibility should not compromise food hygiene objectives. Moreover, since all food produced in accordance with the hygiene rules will normally be in free circulation throughout the Community, the procedure allowing Member States to exercise flexibility should be fully transparent. Article 10, paragraph 1

1. Annexes II and III may be ***repealed, amended,*** adapted or ***supplemented,*** in accordance with the procedure referred to in Article 12(2), ***to take account of:***

- (a) the development of guides to good practice;
- (b) the experience gained from the implementation of HACCP-based systems pursuant to Article 5 of Regulation (EC) No /2003 *;
- (c) technological developments;
- (d) changes in patterns of consumption;
- (e) scientific advice, particularly new risk assessments;
- (f) ***the setting of food safety targets.***

1. Annexes II and III may be adapted or ***updated*** in accordance with the procedure referred to in Article 12(2), ***taking into account :***

- (a) the development of guides to good practice;
- (b) the experience gained from the implementation of HACCP-based systems pursuant to Article 5 of Regulation (EC) No. .../2003;
- (c) ***the*** technological developments ***and their practical consequences and consumer expectations with regard to food composition;***
- (d) scientific advice, particularly new risk assessments;
- (e) ***microbiological and temperature criteria for foodstuffs;***
- (f) changes in patterns of consumption.

Amendment 11

Annex III, section IV, chapter I, paragraphs 2 and 3

2. *At least one member of every* hunting team **must have** the knowledge referred to in paragraph 1. References in this Section to a "trained person" are references to that person.

3. The trained person **may** be the gamekeeper or the game manager if he or she is part of the hunting team or located in the immediate vicinity of where hunting is taking place. In the latter case, the hunter must present the wild game to the gamekeeper or game manager and inform them of any abnormal behaviour observed before killing.

2. *It is however enough if at least one person of a* hunting team **has** the knowledge referred to in paragraph 1. References in this Section to a "trained person" are references to that person.

3. The trained person **could also** be the game keeper or the game manager if he or she is part of the hunting team or located in the immediate vicinity of where the hunting is taking place. In the latter case, the hunter must present the wild game to the gamekeeper or game manager and inform them of any abnormal behaviour observed before killing.
