

At its sittings of 30 May 2002 and 11 March 2004 Parliament adopted its position at first reading on the proposal for a European Parliament and Council decision amending Decision No 1692/96/CE on Community guidelines for the development of the trans-European transport network (COM(2001) 544 and COM(2003) 564 – 2001/0229(COD)).

At the sitting of 19 April 2004 the President of Parliament announced that the common position had been received and referred to the Committee on Regional Policy, Transport and Tourism (5762/1/2004 – C5-0184/2004).


The committee had appointed Philip Charles Bradbourn rapporteur at its meeting of 20 November 2001.

It considered the common position and the draft recommendation for second reading at its meeting of 19 April 2004.

At the same meeting it adopted the draft legislative resolution by 25 votes to 3, with 3 abstentions.


on the Council common position for adopting a European Parliament and Council decision amending Decision No 1692/96/CE on Community guidelines for the development of the trans-European transport network (5762/1/2004 - C5-0184/2004 - 2001/0229(COD))

(Codecision procedure: second reading)

The European Parliament,

- having regard to the Council common position (5762/1/2004 C5-0184/2004),
- having regard to its position at first reading¹ on the Commission proposals to Parliament and the Council (COM(2001) 544² and COM(2003) 564³),
- having regard to the amended proposal (COM(2002) 542)⁴
- having regard to Article 251(2) of the EC Treaty,
- having regard to Rule 78 of its Rules of Procedure,
- having regard to the recommendation for second reading of the Committee on Regional Policy, Transport and Tourism (A5-0278/2004),
- 1. Approves the common position;
- 2. Notes that the act is adopted in accordance with the common position;
- 3. Instructs its President to sign the act with the President of the Council pursuant to Article 254(1) of the EC Treaty;
- 4. Instructs its Secretary-General duly to sign the act and, in agreement with the Secretary-General of the Council, to have it published in the Official Journal of the European Union;
- 5. Instructs its President to forward its position to the Council and Commission.
