

The European Parliament,

- having regard to the Commission proposal to the Council (COM(2003)0639)¹,
- having regard to the modified proposal by the Council (6018/2004),
- having regard to Article 181a (2) of the EC Treaty, pursuant to which the Council consulted Parliament (C6-0078/2004),
- having regard to Rule 51 of its Rules of Procedure,
- having regard to the report of the Committee on Foreign Affairs and the opinion of the Committee on Development (A6-0041/2004),
- 1. Approves the Commission proposal as modified by the Council;
- 2. Calls on the Council to notify Parliament if it intends to depart from the text approved by Parliament;
- 3. Asks the Council to consult Parliament again if it intends to amend the Commission proposal substantially;
- 4. Instructs its President to forward its position to the Council and Commission.


PROCEDURE

By letter of 28 October 2003 the Commission submitted to Parliament, pursuant to Articles 251(2), 179(1) and 181a(2) of the EC Treaty, the proposal for a European Parliament and Council Regulation amending Regulation (EC) No 975/1999 laying down the requirements for the implementation of development cooperation operations which contribute to the general objective of developing and consolidating democracy and the rule of law and to that of respecting human rights and fundamental freedoms (COM(2003) 639 – 2003/0250(COD)) and regulation (EC) No 976/1999 laying down the requirements for the implementation of Community operations, which, within the framework of Community cooperation policy, contribute to the general objective of developing and consolidating democracy and the rule of law and to that of respecting human rights and fundamental freedoms in third countries (COM(2003) 639 - C5-0078/2004 - 2004/0807(CNS)).

At the sitting of 5 November 2003 the President of Parliament announced that he had referred the proposal to the Committee on Foreign Affairs, Human Rights, Common Security and Defence Policy as the committee responsible and to the Committee on Development and Cooperation and the Committee on Budgets for their opinions (C5-0507/2003).

At the sitting of 18 December 2003 the President of Parliament announced that the Committee on Development and Cooperation would be involved in drawing up its opinion pursuant to rule 162a.

The Committee on Foreign Affairs, Human Rights, Common Security and Defence policy appointed Edward H.C. McMillan-Scott rapporteur at its meeting of 8 July 2003, the Committee on Development and Cooperation appointed Fernando Fernández Martín draftsman at its meeting of 9 July 2003, the Committee on Budgets appointed Gianfranco



Dell'Alba draftsman at its meeting of 26 November 2003.

On 13 February, the Director General of the legal service of the Council wrote to the president of the Parliament explaining that "regulation 975 and regulation 976 being two separate legal instruments with different scope of application, it has been considered that each of the amending regulations has to be adopted separately".

On 1 April, the Conference of Presidents of the Parliament decided to attribute regulation n° 975/1999 to the Committee on Development and Cooperation (under co-decision procedure) and regulation n° 976/1999 to the Committee on Foreign Affairs, Human Rights, Common Security and Defence policy (under consultation procedure).

Fernando Fernández Martín has been confirmed as draftsman for opinion on the 27 July 2004.

On 6 October 2004, the Committee on Development adopted its draft opinion on regulation n° 976/1999 by 24 votes with one abstention.

AMENDMENTS

The Committee on Development calls on the Committee on Foreign Affairs, as the committee responsible, to incorporate the following amendments in its report:

Amendment 1 ARTICLE 2, POINT -1 (new) Article 3, paragraph 2, point h (new) (Regulation (EC) No 976/1999)

(-1)The following point is inserted in Article 3(2):

"(h) supporting efforts to foster the establishment of groupings of democratic countries within United Nations bodies, specialised agencies and regional organisations."

Amendment 2 ARTICLE 2, POINT 1 Article 5, paragraph 1 (Regulation (EC) No 976/1999)

The following sentence is added at the end of the *first paragraph of Article 5*:

"In *duly justified cases* natural persons are eligible for financing under this Regulation."

The following sentence is added at the end of *Article 5*, *paragraph 1*:

"In the case of EU election observation missions and 'amicus curiae' proceedings natural persons are eligible for financing under this Regulation."

Amendment 3 ARTICLE 2, POINT 5 Article 12 (Regulation (EC) No 976/1999)

1. The Commission shall adopt the framework for the programming and identification of Community activities.

- (a) multiannual indicative programmes and annual updates of these programmes,
- (b) annual work programmes.

2. The Commission shall produce an annual report setting out programming for the coming year by region and by sector, and shall report back on the implementation to the European Parliament.

The Commission shall be responsible for managing and adapting, in conformity with this Regulation and according to the requirements of flexibility, the annual work programmes that were defined in the overall framework of the multiannual setting. The decisions made shall reflect the priorities and main concerns of the European Union for the consolidation of democracy, the rule of law and respect for human rights, and shall be determined by the unique nature of the programmes. The Commission shall keep the European Parliament fully informed of the proceedings.

3. The Commission shall implement Community operations under this Regulation in accordance with the budgetary and other procedures in force, in particular those laid down in Council Regulation (EC, Euratom) No 1605/2002.
