

(Consultation procedure)

The European Parliament,

having regard to the Commission proposal to the Council (COM(2006)0004 final)¹,

- having regard to Article 37 of the EC Treaty, pursuant to which the Council consulted Parliament (C6-0042/2006),
- having regard to Rules 51 and 43(1) of its Rules of Procedure,
- having regard to the report of the Committee on Legal Affairs (A6-0259/2006),
- 1. Approves the Commission proposal;
- 2. Calls on the Council to notify Parliament if it intends to depart from the text approved by Parliament;
- 3. Asks the Council to consult Parliament again if it intends to amend the Commission proposal substanitally;
- 4. Instructs its President to forward its position to the Council and the Commission.
