



on the proposal for a Council decision on Community strategic guidelines on cohesion (11807/2006-C6-0266/2006-2006/0131(AVC))

#### (Assent procedure)

The European Parliament,

- having regard to the proposal for a Council decision (11807/2006),
- having regard to the request for assent submitted by the Council pursuant to Article 161 of the EC Treaty (C6-0266/2006),
- having regard to its resolution of 18 May 2006 on preparing for the assent procedure for the Community's strategic guidelines for the period 2007-2013 (Cohesion Policy in Support of Growth and Jobs)<sup>1</sup>, which occasioned an early dialogue between the European Commission and the European Parliament which should be repeated prior to the mid-term review of the Community strategic guidelines provided for by Article 26 of Council Regulation (EC) No 1083/2006 of 11 July 2006 laying down general provisions on the European Regional Development Fund, the European Social Fund and the Cohesion Fund<sup>2</sup>,
- having regard to Rule 75(1) of its Rules of Procedure,
- having regard to the recommendation of the Committee on Regional Development (A6-0281/2006),
- 1. Gives its assent to the proposal for a Council decision;
- 2. Instructs its President to forward its position to the Council and Commission.
