

on the Council common position for adopting a decision of the European Parliament and of the Council establishing a Community Programme for Employment and Social **Solidarity - PROGRESS** 

(6282/3/2006 - C6-0272/2006 - 2004/0158(COD))

#### (Codecision procedure: second reading)

The European Parliament,

- having regard to the Council common position (6282/3/2006 C6-0272/2006),
- having regard to its position at first reading<sup>1</sup> on the Commission proposal to Parliament and the Council (COM(2004)0488)<sup>2</sup>,
- having regard to the amended Commission proposal (COM(2005)0536)<sup>3</sup>,
- having regard to Article 251(2) of the EC Treaty,
- having regard to Rule 67 of its Rules of Procedure,
- having regard to the recommendation for second reading of the Committee on Employment and Social Affairs (A6-0300/2006),
- 1. Approves the common position;
- 2. Notes that the act is adopted in accordance with the common position;
- 3. Instructs its President to sign the act with the President of the Council pursuant to Article 254(1) of the EC Treaty;
- 4. Instructs its Secretary-General to sign the act, once it has been verified that all the procedures have been duly completed, and, in agreement with the Secretary-General of the Council, to have it published in the Official Journal of the European Union;
- 5. Instructs its President to forward its position to the Council and Commission.
