



DRAFT EUROPEAN PARLIAMENT LEGISLATIVE RESOLUTION

on the Council common position for adopting a directive of the European Parliament and of the Council amending Council Directive 76/769/EEC relating to restrictions on the marketing of certain measuring devices containing mercury (5665/1/2007 – C6-0114/2007 – 2006/0018(COD))

(Codecision procedure: second reading)

The European Parliament,

- having regard to the Council common position (5665/1/2007 C6-0114/2007),
- having regard to its position at first reading¹ on the Commission proposal to Parliament and the Council (COM(2006)0069)²,
- having regard to Article 251(2) of the EC Treaty,
- having regard to Rule 67 of its Rules of Procedure,
- having regard to the recommendation for second reading of the Committee on the Environment, Public Health and Food Safety (A6-0218/2007),
- 1. Approves the common position;
- 2. Notes that the act is adopted in accordance with the common position;
- 3. Instructs its President to sign the act with the President of the Council pursuant to Article 254(1) of the EC Treaty;
- 4. Instructs its Secretary-General to sign the act, once it has been verified that all the procedures have been duly completed, and, in agreement with the Secretary-General of the Council, to have it published in the Official Journal of the European Union;
- 5. Instructs its President to forward its position to the Council and Commission.


EXPLANATORY STATEMENT

The Council common position includes most of the amendments adopted by the European Parliament on 14 November 2006. It corresponds in fact to the text on which, following the discussions with the rapporteur and the shadow rapporteurs, the Council had offered its availability for a conclusion of the legislative procedure in first reading.

The main difference between Parliament's position and the common position concerns the use of mercury in barometers. While Parliament voted in favour of a full derogation on this issue, Council proposes a time-limited derogation of two years after the entry into force of the Directive. The ban would in any case only apply to new mercury barometers, while those already in use and on the second hand market could still be sold, repaired and maintained.

There are only few manufacturers of mercury barometers in the EU, mainly SMEs located in the UK, Belgium and the Netherlands. Alternative mercury-free traditional barometers are already now sold in the UK.

Your rapporteur believes that, in the light of the very hazardous properties of mercury and of the much larger amount of mercury contained in traditional barometers in comparison for example with fever thermometers, the solution proposed by the Council to grant a temporary derogation in order to allow the manufacturers of traditional barometers to adapt to the new situation is a balanced compromise. She therefore recommends the approval of the common position without amendment.
