



DRAFT EUROPEAN PARLIAMENT LEGISLATIVE RESOLUTION

on the proposal for a Council decision on the conclusion of the Agreement between the European Community and Bosnia and Herzegovina on the facilitation of issuance of short-stay visas

(COM(2007)0423 - C6-0296/2007 - 2007/0140(CNS))

(Consultation procedure)

The European Parliament,

- having regard to the proposal for a Council decision (COM(2007)0423)¹,
- having regard to Articles 62(2)(b)(i) and (ii) and 300(2), first subparagraph, first sentence, of the EC Treaty,
- having regard to Article 300(3), first subparagraph, of the EC Treaty, pursuant to which to Council consulted Parliament (C6-0296/2007),
- having regard to Rules 51 and 83(7) of its Rules of Procedure,
- having regard to the report of the Committee on Civil Liberties, Justice and Home Affairs and the opinion of the Committee on Foreign Affairs (A6 0384/2007),
- 1. Approves conclusion of the agreement;
- 2. Instructs its President to forward its position to the Council and Commission, and the governments and parliaments of the Member States and of the Republic of Bosnia and Herzegovina.

EXPLANATORY STATEMENT


The Civil Liberties, Justice and Home Affairs Committee (LIBE) approves conclusion of two, mutually conditional and parallel agreements with Bosnia and Herzegovina on readmission and facilitation of issuance of short-stay visas. The Committee welcomes these agreements, which together with forthcoming Visa Code, implementation of Visa Information System (VIS) and further cooperation in the field of justice and home affairs will extend an area of freedom and security reaching beyond EU.

The Committee believes that in the spirit of joint commitment and ownership, EU and Bosnia and Herzegovina can effectively fight illegal immigration and contribute to the development of democracy, rule of law, human rights and civil society by encouraging easier contact and travel of people between two contracting parties. In this context, the Committee welcomes previous decision by the Bosnia and Herzegovina's authorities to abolish visa requirement for EU citizens and is of the opinion that European Union is still in search of adequate response to that decision.

There is also room for improvement on the side of European Commission to launch an information campaign and to find means and ways to make all the necessary information easily accessible to all travellers in the light of these and other agreements concluded. So far, even Commission's website does not contain any systematic and transparent information on this subject.

It is strongly recommended for the committee monitoring implementation of these agreements as well as to the European Commission itself to identify any asymmetrical barriers preventing from reciprocate procedures becoming obstacles for travellers at the consulates, as well as, at the border crossings. In particular a study must be carried whether partial outsourcing of visa consular services may have an impact on the accessibility and possible undesired increase of visa prices or creating visa-shopping phenomenon.

Finally, the LIBE Committee expects from the European Commission to provide the Parliament with information on the results of the implementation of the agreements.

SHORT JUSTIFICATION

The European Parliament has been consistently calling for a relaxation of the draconian visa regime which was imposed on the countries belonging to the former Yugoslavia. This regime, which contrasts sharply with the pre-war conditions that applied to Yugoslavian citizens, has been particularly pernicious for the social and economic development of the countries of south-eastern Europe.

Rather than serving its original purpose, notably that of preventing local criminal networks from extending their activities outside the region, it has prevented honest students, academics, researchers and businessmen from developing close contacts with partners in the EU countries. A sense of isolation, of undeserved discrimination, of ghettoisation has prevailed, particularly amongst the youngest, which has undermined their European identity. Europe is a prosperous society to which they would like to belong but from which they feel rejected.


In the meantime, criminals have expanded their networks, forged alliances with fellow organisations in the EU Member States and expanded their activities in our territories, all this despite the visa restrictions which currently apply.

It is therefore legitimate to question the very foundations of the visa policy which the Union has applied so far towards the countries of south-eastern Europe. Much more emphasis should be placed on regional cooperation in the fight against organised crime and trafficking, with more funds and programmes being directed at upgrading facilities, training and better remuneration for staff, and promoting more sophisticated technologies. All this costs money, and this is where the Union should show solidarity. It is in the interests not just of these countries but also of the Union to develop efficient, reliable and corruption-free border control forces, police and public administration. Assistance under the Pre-Accession

Instrument should therefore be stepped up, with additional funds being provided for this purpose.

By providing such (financial and technical) assistance the Union would enable these countries to fulfil the requirements for the next step: visa liberalisation. The European Parliament, and the Committee on Foreign Affairs in particular, strongly advocate lifting as soon as technically possible the visa requirements for citizens of the region. In our view, this would be a tangible sign that their countries belong to Europe. It would encourage them to take resolute action to adopt the reforms which will eventually lead them to full membership of the European Union.

The Committee on Foreign Affairs calls on the Committee on Civil Liberties, Justice and Home Affairs, as the committee responsible, to propose approval of the Commission proposal.
