



DRAFT EUROPEAN PARLIAMENT LEGISLATIVE RESOLUTION


on the proposal for a regulation of the European Parliament and of the Council amending Regulation (EC) No 91/2003 of the European Parliament and of the Council of 16 December 2002 on rail transport statistics, as regards the collection of data on goods, passengers and accidents

(COM(2013)0611 - C7-0249/2013 - 2013/0297 (COD))

(Ordinary legislative procedure: first reading)

The European Parliament,

- having regard to the Commission proposal to Parliament and the Council (COM(2013)0611),
- having regard to Article 294(2) and Article 338(1) of the Treaty on the Functioning of the European Union, pursuant to which the Commission submitted the proposal to Parliament (C7-0249/2013),
- having regard to Article 294(3) of the Treaty on the Functioning of the European Union,
- having regard to Rule 55 of its Rules of Procedure,
- having regard to the report of the Committee on Transport and Tourism (A7-0002/2014),
- 1. Adopts its position at first reading hereinafter set out;
- 2. Calls on the Commission to refer the matter to Parliament again if it intends to amend its proposal substantially or replace it with another text;
- 3. Instructs its President to forward its position to the Council, the Commission and the national parliaments.



Proposal for a regulation Recital 3 a (new)

Text proposed by the Commission

Amendment

(3a) Eurostat should closely cooperate with the European Railway Agency in the collection of rail accident data in order to ensure that the data obtained are consistent and fully comparable. The role of the European Railway Agency in the field of rail safety should be continuously enhanced.

Justification

The efficient cooperation between both institutions is necessary in order to ensure that the collected data is compatible and consistent and to avoid any possible disruptions arising from the transition of responsibilities from Eurostat to the European Railway Agency.

Text proposed by the Commission

(7) In its report to the European Parliament and the Council on the experience acquired in the application of the Regulation (EC) No 91/2003, the Commission mentions that long term developments will probably mean the suppression or simplification of the data already collected under the Regulation, and that the intention is to reduce the data transmission period for annual data on rail passengers.

The Commission should, when preparing and drawing up delegated acts, ensure simultaneous, timely and appropriate submission of the relevant documents to the European Parliament and to the Council.

(10) It is particularly important that the Commission carry out the appropriate consultations during its preparatory work, including at expert level, *and that it take into account the position of the rail sector*. The Commission should, when preparing and drawing up delegated acts, ensure simultaneous, timely and appropriate submission of the relevant documents to the European Parliament and to the Council.

Justification

When preparing and drawing up delegated acts, the Commission should consult the rail sector to ensure that the position of rail companies, as providers and users of rail transport statistics, is sufficiently taken in to account.

Report

- (a) assess the benefits accruing to the Union, the Member States and the providers and users of statistical information of the statistics produced, in relation to their costs;
- (b) assess the quality of the statistics produced, especially with regards to data losses, resulting from the deletion of simplified reporting;
- (c) identify areas for potential improvement and any amendments considered necessary in the light of the results obtained.'.

Justification

It must be ensured that efforts to lower the burden on data providers does not result in a substantial loss of data quality, especially those resulting from the deletion of the simplified reporting.

EXPLANATORY STATEMENT

Background

Regulation (EC) No 91/2003, which the Commission proposes to amend, establishes common rules for the production of Union rail transport statistics. Data collected within this framework cover goods and passenger transport, as well as data collected on traffic flows on the rail network and on accidents.

The Commission proposal

The proposal simplifies Regulation (EC) No 91/2003 by preserving only 'detailed' reporting requirements and abandoning the current concept of 'simplified' reporting, thus reducing the burden on Member States and respondents, with no significant loss in the quality of data for the transport of goods and passengers by rail, and shortening the timelines for disseminating passenger rail data.

For smaller undertakings below the specified thresholds, Member States would have to report an 'overall' figure for aggregated indicators in a separate Annex.

The Commission proposes to delete the requirement to collect data on accidents, as these statistics are also collected by the European Rail Agency (ERA).

Finally, the proposed amendment of Regulation (EC) No 91/2003 takes into account the adjustments to the Treaty on the Functioning of the European Union, as regards granting the Commission delegated and implementing powers.

Rapporteur's view

Your Rapporteur welcomes the Commission's intention to simplify rules for the generation of Union rail transport statistics, and to align the existing comitology provisions to delegated and implementing acts.

However, the Rapporteur is of the opinion that data collection should be extended further to rail infrastructure data, and that more measurement variables in statistics on passenger transport should be included, in particular with regard to cross-border connections that should be at the heart of the EU's transport policy. He proposes to add a few classes of data, such as the number and type of trains, bicycles carried (based on Article 6 of the Rail Passenger Regulation), the number of new and retro-fitted silent freight waggons equipped with composite brake blocks (based on the new Connecting Europe Facility (CEF) Regulation).

Your Rapporteur is also of the opinion that there is a need for streamlining the powers delegated to the Commission to safeguard the Parliament's prerogatives.

Your Rapporteur believes that the requirement to collect data on accidents should not be taken away from Eurostat. Instead, cooperation on data collected has to be ensured and put in place with the European Rail Agency. Moreover, a requirement to collect data on incidents has to be added, since this contributes to a higher level of rail safety.
