



DRAFT EUROPEAN PARLIAMENT LEGISLATIVE RESOLUTION

on the Council position at first reading with a view to the adoption of a regulation of the European Parliament and of the Council amending Council Regulation (EC) No 515/97 on mutual assistance between the administrative authorities of the Member States and cooperation between the latter and the Commission to ensure the correct application of the law on customs and agricultural matters (08257/3/2015 – C8-0159/2015 – 2013/0410(COD))

(Ordinary legislative procedure: second reading)

The European Parliament,

- having regard to the Council position at first reading (08257/3/2015 C8-0159/2015),
- having regard to the opinion of the Court of Auditors of 25 February 2014¹,
- having regard to its position at first reading² on the Commission proposal to Parliament and the Council (COM(2013)0796),
- having regard to Article 294(7) of the Treaty on the Functioning of the European Union,
- having regard to Rule 76 of its Rules of Procedure,
- having regard to the recommendation for second reading of the Committee on the Internal Market and Consumer Protection (A8-0234/2015),
- 1. Approves the Council position at first reading;
- 2. Notes that the act is adopted in accordance with the Council position;
- 3. Instructs its President to sign the act with the President of the Council, in accordance with Article 297(1) of the Treaty on the Functioning of the European Union;
- 4. Instructs its Secretary-General to sign the act, once it has been verified that all the procedures have been duly completed, and, in agreement with the Secretary-General of the Council, to arrange for its publication, in the *Official Journal of the European Union*;
- 5. Instructs its President to forward its position to the Council, the Commission and the national parliaments.


