78a. Strongly denounces, following the recent ‘Azerbaijani Laundromat’ revelations, attempts by Azerbaijan and other autocratic regimes in third countries to influence European decision-makers through illicit means; calls for a comprehensive Parliament investigation into the abovementioned allegations and, more broadly, into the influence exerted by such regimes; calls for the adoption by Parliament of robust measures to prevent the occurrence of such corruption, which would undermine the credibility and

*legitimacy of Parliament's work,
including on human rights;*
