The first and second lines of the header of each amendment identify the relevant part of the draft act under consideration. If an amendment pertains to an existing act that the draft act is seeking to amend, the amendment heading includes a third line identifying the existing act and a fourth line identifying the provision in that act that Parliament wishes to amend.

#### **Amendments by Parliament in the form of a consolidated text**

New text is highlighted in ***bold italics***. Deletions are indicated using either the **■** symbol or strikeout. Replacements are indicated by highlighting the new text in ***bold italics*** and by deleting or striking out the text that has been replaced.

By way of exception, purely technical changes made by the drafting departments in preparing the final text are not highlighted.

## **DRAFT EUROPEAN PARLIAMENT LEGISLATIVE RESOLUTION**

**on the draft Council regulation on jurisdiction, the recognition and enforcement of decisions in matrimonial matters and matters of parental responsibility, and on international child abduction (recast)  
(15401/2018 – C8 0023/2019 – 2016/0190(CNS))**

**(Special legislative procedure – renewed consultation)**

*The European Parliament,*

- having regard to the Council draft (15401/2018),
  - having regard to the Commission proposal to the Council (COM(2016)0411),
  - having regard to its position of 18 January 2018<sup>1</sup>,
  - having regard to Article 81(3) of the Treaty on the Functioning of the European Union, pursuant to which the Council consulted Parliament again (C8-0023/2019),
  - having regard to Rules 50(1), 78c and 78e of its Rules of Procedure,
  - having regard to the report of the Committee on Legal Affairs (A8-0056/2019),
1. Approves the Council draft as amended;
  2. Calls on the Commission to alter its proposal accordingly, pursuant to Article 293(2) of the Treaty on the Functioning of the European Union;
  3. Calls on the Council to notify Parliament if it intends to depart from the text approved by Parliament;
  4. Calls on the Council to consult Parliament again if it intends to amend its draft substantially;
  5. Instructs its President to forward its position to the Council, the Commission and the national parliaments.
