4a. Stresses that tax fraud, tax evasion and aggressive tax planning result in lost resources for the Member States' and the Union's budgets; deplores the lack of reliable and unbiased statistics on the magnitude of tax avoidance and tax evasion and stresses the importance of developing appropriate and transparent methodologies to quantify the scale of these phenomena, as well as their impact on public finances and, by extension, on the Union's financial resources; calls on Eurostat to provide technical assistance for the collection of comprehensive and accurate statistics; calls for Europol to be allocated the requisite resources for it to establish a financial police force and increase its capacity to investigate tax fraud, money laundering and financial crime; stresses the importance of evaluating the use of harmful tax practices by certain Member States prior to the effective implementation of the various budget programmes;
