



DRAFT EUROPEAN PARLIAMENT LEGISLATIVE RESOLUTION

(Ordinary legislative procedure: second reading)

The European Parliament,

- having regard to the Council position at first reading (08143/1/2023 C9-0222/2023),
- having regard to the opinion of the European Economic and Social Committee of 7 May 2020¹.
- having regard to its position at first reading² on the Commission proposal to Parliament and the Council (COM(2019)0619),
- having regard to Article 294(7) of the Treaty on the Functioning of the European Union,
- having regard to the provisional agreement approved by the committee responsible under Rule 74(4) of its Rules of Procedure,
- having regard to Rule 67 of its Rules of Procedure,
- having regard to the recommendation for second reading of the Committee on Fisheries (A9-0243/2023),
- 1. Approves the Council position at first reading;
- 2. Notes that the act is adopted in accordance with the Council position;
- 3. Instructs its President to sign the act with the President of the Council, in accordance with Article 297(1) of the Treaty on the Functioning of the European Union
- 4. Instructs its Secretary-General to sign the act, once it has been verified that all the procedures have been duly completed, and, in agreement with the Secretary-General of the Council, to arrange for its publication in the *Official Journal of the European Union*;
- 5. Instructs its President to forward its position to the Council, the Commission and the national parliaments.



SHORT JUSTIFICATION

The Council position at first reading reflects the agreement reached between Parliament and the Council in interinstitutional negotiations at early second-reading stage.

The provisional agreement resulting from these interinstitutional negotiations was confirmed by the Permanent Representatives Committee (Coreper) on 5 April 2023 and approved by the Committee on Fisheries of the Parliament on 26 April 2023.
