Inter alia, the assessment shall analyse alignment with the General Data Protection Regulation, Data Governance Act, Data Act, AI Act and the Regulations on cybersecurity.

3 a. The Commission shall be empowered to adopt, by ... [12 months after the date of entry into force of this Regulation], delegated acts to supplement this Regulation in order to:

(a) set out the common result and impactoriented indicators to be used for reporting on the progress and for the purpose of monitoring and evaluation of this Regulation;

(b) measure the costs, benefits and other health and economic results, including trends per Member State, in order to compare the effectiveness of implementation of this Regulation; and

(c) define a methodology for reporting by *Member States.*

The Commission shall regularly revise and, if necessary, update the common indicators.
