- Sven Simon (PPE) was appointed rapporteur for the opinion on Proposed amendments to Protocol No 3 on the Statute of the Court of Justice of the European Union (2022/0906 (COD)).
- Due to calendar restraints, amendments to the report on the Composition of the European Parliament (co-rapporteurs: Loránt Vincze (PPE), Sandro Gozi (Renew) should be tabled in English only.

The Chair also made the following general announcements:

- The Chair informed Members about the COSAC Chairpersons' meeting in Stockholm on 29-30 January 2023, during which participants held an exchange of views on the priorities of the Swedish Presidency and on current challenges for the EU with regard to combating organised crime. This meeting was preceded by the meeting of the COSAC Presidential Troika, which held a political debate on the priorities of the Swedish Presidency, with a particular emphasis on organised crime.
- The Chair announced that the deadline for submission of proposals for Pilot Projects and Preparatory Actions is Friday 24 March 2023 (COB).
