- Adoption of draft report

The draft report (Annex) as amended was adopted with 19 votes in favour, 6 votes against and 1 abstention. The draft report (Motion for resolution) as amended was adopted with 20 votes in favour, 6 votes against and no abstention. All compromise amendments (1-12), as well as amendments 1-8, 13-19, 21-24, 26-60, 62-74, 76-79, 81-83, 86-95, 98-99, 101, 103-112, 114-115, 117-130, 132-167, 169-267 and amendment 561 (identical to amendment CONT 560) were adopted. All other amendments were rejected or fell.

After the vote, Loránt Vincze (4th Vice-Chair, PPE) requested a correction of vote as shown in the annex with the results of the roll-call votes. This does not change the result of the vote.
