

22a. Calls on Georgia to provide comprehensive information related to Association Agreement between the European Union and the European Atomic Energy Community and their Member States, of the one part, and Georgia, of the other part to the Georgian society, including Abkhazia and South

Ossetia territories, in cooperation with EU Special Representative of South Caucasus and the Crises in Georgia and the EU Monitoring Mission (EUMM);
