**FINAL RECORD OF DECISIONS**

**I. CHAIR'S ANNOUNCEMENTS**

**A. Decisions of EP authorities on going back to physical working conditions**

The Chair recalled the decision of the Conference of Presidents of 2 June 2022, whereby as of 13 June 2022 committee votes, trilogues and in camera committee meetings take place in physical presence, with no votes scheduled on Mondays and Fridays (unless required in cases of urgency).

The Chair also recalled that Parliament adopted on 6 July amendments to the rules of procedure that provide some flexibility for committee meetings to be attended remotely. President Metsola has tasked the Conference of Committee Chairs with adopting necessary guidelines for hybrid modalities to be implemented in a harmonised way.

CCC Chair Bernd Lange has also proposed to discuss Annex VI of the EP Rules of Procedure at one of the next CCC meetings. The Chair suggested that AFET Coordinators discuss it at their next meeting and invited the two subcommittees to submit their input in order to have a coordinated approach to AFET contribution to section I of Annex VI of the Rules of Procedure.

**B. Presentation of the 2022 Enlargement Package**

The Chair informed the Coordinators that the 2022 Enlargement Package is tentatively scheduled to be adopted by the Commission on 12 October. As per the long-established practice, an extraordinary meeting will be organised on the same day in the early afternoon so that the Commissioner can present the package to the Committee on Foreign Affairs right after its endorsement by the College.

## **VI. SUBCOMMITTEES**

### **A. DROI**

DROI Coordinators took during their meeting of 15 June 2022 the following decisions:

1. To request the authorisation to draw up
  - a recommendation on **Strengthening the right to participate: legitimacy and resilience of electoral processes in illiberal political systems and authoritarian regimes** (attributed to S&D Group)
  - an own initiative report on the **Situation of children deprived of liberty in the world** (attributed to Renew Group).
2. To organise **briefings and/or debriefs of EU Human Rights Dialogues planned with the Philippines, Cuba, Turkmenistan, Israel, India and Iran.**

**The DROI Coordinators endorsed by written procedure on 7 July the following modified programme of missions:**

- Great Lakes-Democratic Republic of the Congo (Goma, Bukavu and Panzi), to be scheduled for week 44 (5 days and a half, including journey time, from 30 October to 4 November) instead of week 38;
- El Salvador (San Salvador), authorised for week 44, from 30 October to 2 November 2022, 5 days, including journey time – to be rescheduled to the turquoise week in February 2023;
- Pakistan (Islamabad), authorised for week 51, from 19 to 21 December 2022, 5 days, including travel time – to be rescheduled to the turquoise week in September 2022 (20 -22 September);
- Colombian/Venezuelan border, scheduled for the turquoise week of February 2023 – to be brought forward to the turquoise week in December 2022.

The mission to Kazakhstan (Nur Sultan and Almaty), authorised for week 34, from 22 to 24 August 2022, 3 days, including journey time will not be affected.

### **C. AFET Delegation to South Caucasus**

- Following a request from the EPP Coordinator, it was decided to inform the President of the European Parliament and ask for guidance concerning a possible reputational risk for the Parliament in the context of this mission.

### **D. Next meeting**

The next ordinary AFET Coordinators meeting is planned for Thursday 8 September (from 11.30-12.30) in physical presence.
