The Chair informed the Coordinators about the latest agenda of the reflection day of the Conference of Committee Chairs on 7 March.

B. A letter from the CONT Chair to Commissioner Hahn on information about NGOs

The Chair informed the Coordinators about a letter from the Chair of the Committee on Budgetary Control, Monika HOHLMEIER to the Commissioner for Budget and Administration, Johannes Hahn asking for information about funds allocated to “Fight against impunity”, “No peace without justice” and other NGOs. The Commission’s reply was also shared with the Coordinators.

C. Joint AFET/DEVE/DROI meeting with Kevin Casas-Zamora, Secretary-General of International Institute for Democracy and Electoral Assistance

The Coordinators were informed about a joint DEVE/AFET/DROI exchange of views with the International Institute for Democracy and Electoral Assistance (IDEA) and the Swedish Presidency in the context of the mid-term review of the EU Action Plan on Human Rights and Democracy 2020-2024 which was scheduled for 1 March 2023, from 11.00-12.30.

D. AFET own-initiative reports

The Chair updated the Coordinators on the latest state of play of AFET own-initiative reports.
