**FINAL RECORD OF DECISIONS**

**I. CHAIR'S ANNOUNCEMENTS**

**A. AFET key messages for the 2023 Commission Work Programme  
Structured Dialogue**

The Chair informed the Coordinators that in the framework of structured dialogue AFET will hold an exchange of views with VP/HR Borrell on 27 June, 15.00-16.00. The structured dialogue with Commissioner Olivér Várhelyi (Commissioner for Neighbourhood and Enlargement) is being planned and the date will be confirmed. Committees are requested to report the outcome of these exchanges, which will be put together in the Summary Report 2022 that the Conference of Committee Chairs will adopt in June.

The AFET contribution to the summary report should consist of maximum ten key messages (SEDE and DROI should contribute with one key message each, so that in fact AFET has eight key messages). The deadline for submitting the committees' contributions to the CCC is 25 May 2023. Political groups will be asked for contribution before the next Coordinators meeting.

**B. Joint implementation report on the NDICI-Global Europe**

The Chair informed the Coordinators that the Conference of Presidents endorsed the AFET-DEVE report on the implementation of the Neighbourhood, Development and International Cooperation Instrument – Global Europe. As it was the case for the legislative file, the Committee on Budgets (BUDG) will contribute with an opinion under Rule 57 on the budgetary aspects.

**C. CCC reflection day**

The Chair informed the Coordinators about the reflection day of the Conference of Committee Chairs, which took place on 7 March 2023 and the follow-up discussions, which will feed in the Working Group on Parliament reform towards a more modern and efficient Parliament.

#### **D. External expertise for 2023/2024**

The Chair announced that a call for proposals from political groups for AFET external expertise will be launched soon. Coordinators will decide on the subjects at one of the future Coordinators meetings.

  - b) Decision to **replace the ad-hoc delegation to India**, initially **foreseen from 19 to 22 June**, with a **mission to Armenia** (CSDP European Union Advisory Mission Armenia)

### **2. Missions and ad hoc delegations in the second half of 2023**

- b) **Israel/Palestine** (EU Coordinating Office for Palestinian Police Support and European Union Border Assistance Mission for the Rafah Crossing Point), i.e. rescheduling the mission originally planned for May 2022,

**DECISION**

1. Decision to endorse DROI priorities for the remainder of the term and programme of DROI activities in the second half of 2023 as follows:

**A. Strategic priorities for the rest of the term**

- 1) The battle of narratives: building convincing narratives on democracy and human rights (presentation of a study, invitation of experts, intellectuals, philosophers),
- 2) Implementing the principles of universality and indivisibility as human rights based approach to DROI agenda and activities,
- ✓ DROI could organise a high level conference jointly with the UN in the presence of major international and regional human rights stakeholders in Brussels on 29 November to celebrate the 75th anniversary of the UDHR and the 30th anniversary of the Vienna Declaration and Programme of Action.
- 3) Fight against impunity (instruments, mechanisms and policies) as a cross-cutting topic of DROI agenda and missions,
- 4) Combatting inequalities and root causes of the violations of human rights,
- 5) Shaping EU external policies from a human rights perspective through using legislative powers,
- 6) Enhanced scrutiny of EU funding and legislation; and appropriate follow-up

to legislative and non-legislative reports adopted during this term and to visits,

- 7) Mainstreaming of human rights in inter-parliamentary delegations to ensure that human rights is dealt with during visits and agenda meetings as core business

### **B. DROI travel activities for second half of 2023**

- 1) **Ukraine** - focus on legal accountability for war crimes - during the green week of July
- 2) **Ethiopia** (Addis Ababa and the Tigray region) during the green week of October/November
- 3) **Lebanon** or **Uzbekistan** (if the visit to Lebanon is not feasible) during the green week of December

### **C. DROI hearings during second half of 2023**

- 1) **The human rights impact of sourcing critical raw materials (sub-issue on Orinoco Mining Arc)**
- 2) **Tackling the root causes of migration, the externalisation of the EU's migration policy and the treatment of refugees and migrants in partner countries in North Africa**

The Coordinators also decided to organise the following exchanges of views:
