### FINAL RECORD OF DECISIONS

#### I. CHAIR'S ANNOUNCEMENTS

##### A. Feedback from the Conference of Presidents - state of play of AFET requests

Coordinators were informed about the decisions of the Conference of Presidents of 6 July 2023, namely:

- The authorisation, on exceptional basis, to draft the three AFET own-initiative reports, which were in excess of the quota, with the following titles: *Role of the European Parliament and its parliamentary diplomacy in the EU's foreign and security policy*, *EU strategy on Central Asia* and *EU-Japan relations* (INTA will be associated under Rule 57 to the report on Japan).
- The endorsement of the requests from AFET, SEDE and DROI to draft the Annual 2023 reports on the *Implementation of the Common Foreign and Security Policy*, *Implementation of the Common Security and Defence Policy* and *Human rights and democracy in the world and the European Union's policy on the matter*.
- The authorisation of the AFET ad-hoc delegation to Tunisia from 14 to 16 September 2023 on the understanding that the mission starts after the end of the part-session and that a limited interpretation regime into one language only applies.

Coordinators were also reminded about the reinstated deadline of maximum six months for the adoption of an own-initiative report.

##### B. Attribution of competence for four requests from the Committee on Foreign Affairs to draft recommendations on the Union's external policies pursuant to Rule 118

The Coordinators were informed that the Conference of Presidents authorised AFET to draw up the four recommendations on the Union's external policies

pursuant to Rule 118 of Parliament's Rules of Procedure on *EU-US relations*, *EU-China relations*, *EU-India relations* and *EU-Russia political relations*.

- With a view to ensuring a consistent treatment of any possible input from INTA to the AFET Rule 118 Recommendations, Coordinators decided to send a letter inviting INTA to confirm as quickly as possible by 5 September 2023, whether it intends to contribute to the trade-related aspects of the abovementioned recommendations, and if so, in which form.
- C. Invitation of Mr Shou Zi Chew to a joint LIBE-AFET-IMCO-ITRE- SEDE committee hearing on TikTok's operations in the European Union

The Chair informed the Coordinators that Mr Shou Zi Chew, Chief Executive Officer of TikTok has politely declined the invitation to appear before the European Parliament in a joint hearing on TikTok's operations in the European Union.

#### D. Commission Work Programme - Summary report 2023

The Chair informed Coordinators that the summary report 2023 on the Commission Work Programme with AFET, SEDE and DROI key messages was transmitted to the President.

#### E. Amendments to the Rules of Procedure concerning the referral of legally binding acts to committees (Rule 48) and the procedure for solving conflicts of competence (Rule 211)

- Coordinators were informed about new amendments to the Rules of Procedure of the European Parliament concerning the referral of legally binding acts to committees (Rule 48) and the procedure for solving conflicts of competence (Rule 211). The new rules became applicable as of 10 July 2023 and will have an impact on the way referrals are handled by the EP administration.

#### F. EU-Mexico Global Agreement

Coordinators were informed about the advancement of the negotiations of the EU-Mexico Global Agreement and agreed to cooperate with INTA on the basis of the same working arrangements as those agreed for the EU-Chile Advanced Framework Agreement. Therefore, a Joint AFET/INTA procedure (Rule, 58) should be followed for the EU-Mexico Global Agreement including a Political and Cooperation pillar and a Trade and Investment pillar (consent and

accompanying resolution). The Interim Free Trade Agreement should be handled by INTA only (consent, without an accompanying resolution).
